Dear Director Stensrud,

This letter is to provide an update on Wasatch Front Consortium (WFC) Alternate Pathway to Professional Educator License (APPEL) Corrective Action Plan dated November 10, 2022. The WFC APPEL Program entered probationary status 11/10/2022. Per R277-301-4 (7), the Board may revoke approval status. The Wasatch Front Consortium has not met the requirements of their Corrective Action Plan and is in violation of Board rules (R277-114, R277-301, R277-303, and R277-304).

Please see the attached documentation that shows the status of each condition of the WFC APPEL Program Corrective Action Plan (CAP). In addition to the outstanding conditions of the CAP, the USBE Educator Licensing Team has received numerous complaints from Wasatch Front Consortium APPEL candidates by phone, email, and in person. These complaints describe a pattern of miscommunication, changing expectations, and Professional Learning Plans (PLPs) that are not consistent with Board rule. We have included several candidate emails.

The WFC APPEL Program CAP states that USBE will remove Wasatch Front Consortium APPEL from probationary status when 95% of the most recent 20 recommended candidates will be approved on initial review. The CAP also states that WFC APPEL Program shall submit a revised PLP for candidate files that USBE Educator Licensing determines do not meet Board rule requirements for a PEL.

According to USBE records, WFC APPEL Program has attempted to recommend 14 APPEL candidates listed below for a professional educator license since 11/10/2022. Nine (9) of those candidates' files met Board rules for a Utah Professional Educator License (PEL) which represents 64% approval on initial review.

The table below shows the date the file was submitted to USBE, whether the file met Board rule requirements for a PEL on initial review, and any communication between WFC APPEL Program and USBE Educator Licensing. Educators are identified by CACTUS number only to protect their privacy.

To date, the WFC APPEL program has successfully recommended 9 out of 14 candidates on first review, or 64% of the most recent 14 recommended candidates.

Due to the conditions of the CAP not being met and additional evidence that WFC APPEL Program is in violation of aforementioned Board rules, Educator Licensing recommends the Board revoke approval status of the Wasatch Front Consortium APPEL Program and direct USBE licensing staff to work with enrolled educators to complete their PLPs.
