A minimum number of requirements have been met and/or competencies demonstrated.

3. Local Education Agency (LEA) Specific

Under direction of the local governing boards of school districts or charters. Typically, educators who have not yet met the Associate requirements.



Number of Professional License Areas by Area – SY2023





Timeline of Application Method

- Prior to Fall 2020: All applications submitted on physical paper.
- Fall 2020 Fall 2022: Applications submitted via email; accepted on physical paper submitted in-person or via mail.
- Fall 2022 March 2023: All applications submitted digitally via email.
- March 2023: SM Apply software implemented for Out-of-State/License Equivalency Review applications.
- June 2023: SM Apply software for non-CTE endorsements and Associate Educator License applications.
- October 2023: SM Apply software for all applications.




SM Apply Application Platform

- Fully digital, web-based platform
- Allows applicants to track the status of their application in real-time
- Creates a workflow management for the licensing team
- Allows licensing team to prioritize application review for US military families
- Able to translate application into Spanish and French
- Automated notifications sent to applicants for each step of the application review process
- Creates a reliable audit trail for all applications and reviews
- Significantly reduces application processing time
