1. Welcome

Chair Koopman called the meeting to order at 1:01 p.m.

2. Approval of minutes of the September 20, 2023 meeting

Chair Koopman asked for a vote to approve the September 20, 2023 minutes.

MOTION: Commissioner Farnsworth moved that the minutes of the September 20, 2023 meeting be

approved. The motion passed unanimously, with Commissioners Sonnenreich and Squires being absent. [Please refer to 00:04:00 in the recording to hear the motion.]

3. License Plate Reader (LPR) Presentations

Washington County Sheriff's Office

Lt. Aaron Thompson from the Washington County Sheriff's Office shared that Washington County currently has three different types of LPRs: Quick-Deploy, Mobile, and App-Based Scanners. Lt. Thompson discussed how these different types of LPRs are used and how those uses have changed under recent legislation.

Lt. Thompson also provided details about how data from the LPRs is stored, Memorandums of Understanding (MOUs) established for data sharing with other law enforcement agencies (including outside of the State), and how the data searches are audited.

Provo City Parking and Mobility Management

Boden Goulding and Sandy Bussio from Provo City explained how LPRs are used to detect vehicles breaking posted time limits and verify residential parking permits. In Provo, LPRs are only used to enforce parking time limits and other parking restrictions. They do not share their data with other entities or departments in Provo. They follow a 30-day retention schedule and use a virtual internal server built by the parking data management team.

Lone Peak Police Department

Chief Brian Gwilliam of the Lone Peak Police Department discussed the various uses of LPRs in Lone Peak, including providing evidence, as a force multiplier, and as a tool to aid in crime solving. Chief Gwilliam provided details on data retention, access, security, and encryption. He also discussed the department's efforts at transparency and how data is shared and monitored.

Utah Department of Public Safety (DPS)

Capt. Tanner Jensen of DPS talked about the DPS's research into adopting LPR technology, pending the completion of UDOT's permit approval process. As DPS adopts LPR technology, they do have concerns with privacy and data security. Capt. Jensen said that DPS will continue to assess how LPR usage will affect privacy, using the privacy impact assessment tool developed by the Chief Privacy Officer.

Utah Department of Transportation (UDOT)

Leif Elder of UDOT discussed how LPRs are currently being used in the state. Currently, LPRs are only used at points of entry into the state. However, UDOT is in the process of adopting LPRs for other purposes, such as toll roads and HOV lanes. UDOT is also in the process of developing rules for the use of the state rights of way for LPR use by other law enforcement agencies and government entities.

4. Privacy Legislation Concepts (Definitions, State Agencies Duties, Data Breach Notice, Data Privacy Ombudsman, Data Privacy Requests, Data Privacy Complaints)

Representative Jefferson Moss and Chief Privacy Officer Christopher Bramwell provided an update on the Utah Government Privacy Act currently in development. The main purpose of the Act will be to create centralized legislation for all the various privacy-related duties of state agencies.

Commissioners Smith, Farnsworth, and Sonnenreich also presented multiple items that will be included in the bill, such as the creation of a privacy ombudsman and the expectations for reporting data breaches.

5. Data Collection Activities

<u>Utah Department of Transportation (UDOT)</u>

Nathan Lee from UDOT presented on the types of Personally-Identifiable Information (PII) collected for transportation purposes and how that information is administered and protected. Commissioners questioned and discussed the possibility of transponders being used to enforce HOV lane usage.

Utah Department of Natural Resources (DNR)

Kenny Johnson from DNR presented on the data collection involved in hunting and fishing licenses in the state. DNR stated that it only collects the information necessary for the licensing process and for the type of license issued. DNR is planning to modernize its retention plans for all of their data so that they don't keep information longer than necessary.

Jeffrey Johnson and Hilary Renshaw from USHE discussed how treatment records are indirectly protected by FERPA. They also explained how the School Officials Permissive Exception applies to student treatment records, and how it's meant to protect students' privacy.
