Mayor O'Hare stated Good evening, everybody. We'd like to welcome everybody to the Snowville Town incorporated town council meeting on December 13, 2023. I'd like to recognize our council members who are President Rod McGary. LuAnn Johnson and Heather O'Hare. We do have an open seat that is still vacant.

We also like to recognize Stacey Hill, our clerk Tammie Morgan will be here hopefully before the end of the meeting, and I Mayor O'Hare that's here. We are going to start with the pledge from Councilman Rod McGary and following that I will lead us in prayer.

Rod McGary led us in the pledge, I pledge allegiance to the flag of the United States of America, to the Republic for which it stands, one nation under God, indivisible, with liberty and justice for all.

Mayor O'Hare said Of your kind, gracious Heavenly Father, we're very thankful for this opportunity to meet as a town council for the town of Snowville and our Curlew Ward, Curlew Valley, we I would like to thank first off all of our first responders, our police officers, the sheriff's department, the fire department, and EMS, for keeping us safe. Being there when we need them. We ask that you please be with them and all their families during this holiday season so that that keeps them safe while they're out on the road doing their duties. We'd like to thank all of the residents of our town. We'd like to thank our council members and all of our people who served for the town, like to please ask the blessing on us this holiday season, that we're able to have a safe holiday season and recognize the the meaning of this season for the Atonement of Jesus Christ towards our sins. And we asked you to please to be with us as we conclude that or as we go about this meeting, that we are able to

take everything to heart and into our minds and make the right decisions that will benefit this town.

And again, Lord, we thank you for all of our many blessings and we say this name of Thy Son Jesus Christ, amen. Amen.

Mayor O'Hare stated again, thank you everybody for being here tonight. I failed to recognize we also want to recognize the fire chief

Jed and our EMS, President Smith, as well as our Box Elder County Sheriff's Department, Sergeant Eddington, thank you for being here this evening.

The town council was given the agenda and the minutes from last month we were able to look over them. Are there any additions that you have for the agenda for this evening?

And anything for the minutes from last month?

Okay, if all is good, I need a motion to accept the minutes for tonight and the minutes from last month.

Rod McGary said I made a motion to accept the minutes from the prior month and also the agenda for the meeting tonight pretty soon. I have a first from Rod.

LuAnn Johnson Second it. Second. LuAnn second All in favor?

Any opposed?

Okay passed

Mayor O'Hare said and next, we'd like to welcome Jayson Lawor with IDAWY he's taken care of. He's in charge of overseeing the waste management for the town of Snowville. I'd like to welcome you here tonight.

Jayson said sure.

Mayor O'Hare said If you could come up here so we can get you on the recorder thing. Council members, you were given an email from IDAWY that says IDAWY is on top.

And this was an email that we got from Jayson, about the increase in the garbage pickup.

So he's going to explain that to us. And then

we'll have to make a motion. It's on the agenda. So we'll have to make a motion to

or wait a minute. No, we can't do it this month, next month. So this is what's going to increase from IDAWY, and then we'll have to discuss what we're going to do with the town. So Jayson Lawor

Jayson said so first of all, glad to be with you guys. Let me thank you for your service. We serve about 34 towns and cities. So I spend a lot of time with people who sometimes don't get recognized for what they do. So thank you for what you do and Merry Christmas.

IDAWY is a solid waste district I don't remember. I know Stacey's aware of this but for those of you who are new or don't remember, we serve four counties we serve Oneida County, Caribou County, Idaho, Bear Lake County, and now Lincoln County, Wyoming. And then because of the way we travel through here, Snowville approached us and asked us to serve you guys. And it's been a great relationship. And we want to keep it that way. We hope. I talked to a lot of folks in Snowville, I kind of feel like I'm part of the city out here and just wonderful people to serve. So the reason for the increase is the Oneida County Commissioners, we meet on a regular basis, and we have not had an increase since IDAWY, was incepted. And so this is the first increase that we've had. And it's just simply inflationary pressures. You guys know what's happened the last two or three years, it has gone crazy. And we're just meeting costs. So that is what the increase is for. And that affects everybody that Onedia Counties serves, which is you guys because of our relationship with you.

Let me tell you a little bit about what's going on with the landfill. We're building a regional landfill on the Caribou Bear Lake border, we're going to build a transfer station in Oneida. So all that waste will actually be transferred there. It's economies of scale.

We've had a lot going on. So it's been very busy. It's been an interesting several years, as you guys know, we got COVID. And then we have ridiculous growth going on. And then you throw in the national economy, it's been an interesting time to navigate through this process. But things are going well. And we've been successful. And, but we are for the public's knowledge, we're, we're a government entity. We're a solid waste district. So we're not a private entity. We're not for profit, we're here to just pass on the cost that it takes to take care of things. So that's what's going on. Now. I want to answer your questions more than anything because people want to know what's IDAWY or what's going on. And you guys know all about it. But if you have any questions, I'm the guy to ask, I might not have the answers, but I'll get them for you.

Mayor O'Hare asked does any of the council members had questions.

LuAnn asked how much is it going up.

Jayson said \$3. So it's going from \$26 a month to \$29. A second can is still \$5. And then the 300 gallon cans, which are the big commercial ones. There, they went up to \$39 a month, and the second one was \$11. So very nice.

Mayor O'Hare said the 300 gallon, it's \$39.

Jayson said It's \$39. And then each additional was \$11 a month.

Mayor O'Hare said \$11.

Rod said it says \$10. Here

Jayson said in my email.

Rod said Yeah.

Jayson said that's not correct.

Mayor O'Hare said so but it also says it's \$10. Not a month, but no. So it might have just had a couple of misprints.

Jayson Yes.

Rod said Okay. We'll change our notes here accordingly.

Jayson said 2095 is correct.

Rod said okay, thank you.

Mayor O'Hare asked Rod, any more questions? Okay, so I'm gonna take it then. Do you guys roll off containers at all?

Jayson said we do not and we've been approached a lot on that. We will probably get into that. It's not going to be in 24. But we will probably get into that business. Because we've had so many people request that we feel like that's a service that we can provide system-wide.

LuAnn asked what was it.

Mayor O'Hare said roll off the container that we have out of our nonfunctioning dump right now.

Jayson said, Yeah.

Mayor O'Hare said if we were in the plans right now of opening up the town boundaries,

Jayson said okay.

Mayor O'Hare said so if we open up those town boundaries, you'll still take care of those areas?

Jayson said Absolutely.

Mayor O'Hare said okay.

Jayson said.

Mayor O'Hare said one of them is the Cemetery, which is right at the border, but we're getting ready to possibly annex that into the limits. And then, and then outside of on the other side of the highway here. We have boundaries over there.

Jayson said that due to the relationship that we have with you guys, we also serve Howell and Portage. Because I know there's been communication between Snowville residents and Howell and we've been approached by several others. We're not talking anymore right now. Okay. But yes, the question is, yes, yes, we serve, you know, people in Park Valley right now, because it's just so far. And they've got a good setup right now, but anybody else? Absolutely. Yeah. No problem.

Mayor O'Hare said Okay. All right. Yeah. Because right now we have a roll away out there. But we're having some issues right now with the state on this. So I'm trying to find out all the different ways that we can take the state out of the equation here and still have a big enough container to have for our residents who need to dump some extra waste.

Jayson said so they're bringing stuff in so you have.

Mayor O'Hare said so we have roll off for the city. Yeah, for the town, we have a roadway, we call it our dump, okay? And we let we have residents that would call and make an appointment to go out there to dump some extra trash if they had an extra trash box and stuff like that. And a roll away. But the state doesn't have to get permits now because they want all these permits. We're trying to figure out a way not to go around that. Not to go around it but to not deal with the state with them.

Jayson asked how much waste. Do you get that a lot?

Mayor O'Hare said we dumped at what? Twice a year, once a year?

Stacey Hill said I would say maybe 4 times at the max.

Mayor O'Hare said Do we? Okay.

Jayson asked would the 300 gallon cans potentially serve that need.

Mayor O'Hare said Yeah, yeah. I mean, that'd be picked up every week as well. Right?

Jayson said Yes.

Mayor O'Hare said Yeah. I mean, if it was picked up every week because we don't have that many people dump if we had like four of them out there.

Jayson asked what they typically bring into that. Let me ask that.

Mayor O'Hare said well, they're only allowed to bring in waste that they would put in their dumpsters at their house. We're not We're not taking any more metal or copper or anything like that.

LuAnn said We hope.

Jayson said No, I understand. So

Mayor O'Hare said well it's up to these guys. They've got a vote on it. Well, they've actually voted on it. We're not taking it anymore.

Jayson said we understand.

Mayor O'Hare said but yeah, I'm just trying to figure out a way to be able to, we don't I mean, it's just, it's a lot of money. And if we had, what are these \$39 a pop? So \$ 240. Let's just say, for four that would get us 1200 gallons of area. I don't think we would be filling that up in a week. If you're dumping it.

Jayson said you may start out with \$250 bucks a year. That's definitely.

Mayor O'Hare said it's something that's not gonna happen right away. But I just wanted to get the information.

LuAnn asked no matter how much it weighed. You charge \$39 a month?

Jayson said that's correct. Yeah, weight doesn't matter. It's volume.

LuAnn said so what if there's stuff in there that somebody snuck in there when we weren't looking.

Mayor O'Hare said they're not going. Well, they're not going to because it's locked up.

LuAnn said they can jump the damn fence.

Mayor O'Hare said and carried it in.

Jayson said most people 99% of people do the right thing and the 1% we understand. So we get that most 99% of the people because sometimes.

LuAnn said they just throw it over the fence, sometimes they cut the fence and put it wherever they want. So we've had all of that happen.

Jayson said so yeah, however we can, how are we gonna make that work? And we found some there. That's weird. We're gonna probably pull it out.

Mayor O'Hare said the \$39 is to put the barrels out there.

Jayson said Yep.

Mayor O'Hare said to pick it up weekly. Okay.

We'll need to get the numbers. I know, it's a lot more than this. But we'll need to get the numbers on how much it costs for the roll away to drop and to pick up four times a year because I know it's gonna go over \$960. I know that because it's like \$500 bucks for one time. I think. So. Okay.

Yeah, and if we make that decision to do that, then it's just a matter of a few days to get them to get it. Yeah, to get him out here. Perfect.

Perfect.

And those are the same containers that you have at Exit Seven Parking right now. Right?

Jayson said they were Yes.

Perfect. Okay.

Mayor O'Hare said Anybody have any more questions?

Stacy, do you have any questions?

Jayson said let's talk trash guys.

Mayor O'Hare said, anything. Okay.

Jayson said appreciate Stacey. I communicate with her not on a regular basis, but occasionally and I appreciate what you guys use.

Mayor O'Hare said Appreciate you, too. Thank you so much.

Jayson said If you ever want me over here, just please. You know, let her know.

Mayor O'Hare said yeah.

Jayson said I will try to show up every once in a while to try and get out here once a year. So if we have any questions, we'll definitely

Mayor O'Hare said yeah.

Jayson said Don't hesitate to reach out.

LuAnn asked Where is your main office at?

Jayson said, Soda Springs

LuAnn said Soda. So you might know my son, Trevor Neal.

Jayson said Yeah, yeah. Yeah. He's your son.

LuAnn said Yeah.

Jayson said Awesome. We're a little warmer spot over here. LuAnn said yeah.

Jayson said that's great.

Mayor O'Hare said Oh, yeah. One last question. Is there any extra charge if we were to order 300-gallon containers? Just let's just do number four. Okay, if we were to order them to come out here for a week and that's it.

Jayson said So if you want to do a town cleanup, so I'm correct.

Mayor O'Hare said correct.

Jayson said If we had to do something like that, where we just bring out four, or six containers, fill them up, and then you guys haul them off?

Jayson said So let me know if you want to do a city cleanup. Mayor O'Hare said Yeah.

Jayson said I have a trailer that I pulled.

Mayor O'Hare said Okay.

Jayson said We have a couple of trailers that we potentially can drop out here for a week. And make that really can be almost done.

Mayor O'Hare said almost like a roll-off then.

Jayson said it is actually bigger than a roll-off. It is actually about it's the size of a dump truck, this trailer.

Mayor O'Hare said Oh, really.

Jayson said we've got a huge trailer, but I don't think you're going to generate that kind of volume. But be happy to accommodate something like that. And we'll make it reasonable for you as far as the price goes.

Mayor O'Hare said yeah, if you can, yeah, if you can get me a price on that, and just email it over to her what it would cost to have it come out here for a week, or even a couple of days, you know? And then that way, we've got that number in that option as well.

Jayson said Yeah, yeah. If you want to do any cleanup, I'd like it.

Mayor O'Hare said Yeah.

Jayson said we're happy to support that kind of stuff. And we work with all obviously lots.

Mayor O'Hare said that would be great. Yep. Okay. Well, it'd be great if we could keep the relationship with IDAWY and not have to open up a relationship with the state because they are just so, All right, well, appreciate you, Jayson, thank you so much for coming to meet you.

Jayson said Thank you. Merry Christmas. You too. Any questions from the community?

You guys are all happy and your garbage is going away, once a week.

LuAnn said Everything's good. Yes. Wonderful.

Jayson said Thank you so much. All the other Merry Christmas.

Mayor O'Hare said Thank you, Jayson.

Mayor O'Hare said Next on the agenda is a landfill update. So I've been in contact with them, probably every week, for the last month. Speaking with them, I told them, they wanted to know what our what we wanted to do. They sent me the paperwork from 2003 when they decided at that time not to have to do the dump out there. As far as the GreenWaste goes the pit. That's what they were coming to. And that's what they were coming to check back then. This time, there was a complaint filed with the state from somebody who lives. I'm not gonna say but anyway, somebody who lives here in the area filed a complaint. That's why they came out and did the inspection, and then shut everything down.

So anyway, they need to know what we want to do, it's going to be \$125. Quarter, for the permit, to have that roll away out there. We need to get all that metal and stuff out of there as soon as possible and get it sent somewhere. And then it just cost us \$500. A \$500 a year for the permit, and then paid quarterly. And then whatever costs for the roll away.

On top of that, if we're doing the roll away four times we'll get the actual numbers from Stacey.

LuAnn asked how we're still going to charge people.

Mayor O'Hare said Yeah, we're still charging people for dumping.

But that's something that the town council, we need to figure out what you guys how you want to do it, we want to Well, it looks like the garbage is already going to be increased probably because of the or maybe, maybe not, I don't know, we have to go over that it's only \$3 More, do we do a just a regular increase on the garbage that we charge now by five or \$7 per month or \$5 per month. And then the people that live in the town can come and dump as much as you know, as often as they want to.

We need to find out how many residents we have. But that I mean, that's just an option. I mean, or do we charge them individually when they come out to dump? So if we could put that on the agenda next month to come up, vote on a solution for that. And if you guys next month, just bring all your ideas, and then we'll discuss it and go over it.

Stacey said if you're gonna put it on the agenda, you have to have a certain amount you have to have that on the agenda.

Mayor O'Hare said Right

Stacey said so people can see that it's an increase.

Mayor O'Hare said this goes into it doesn't he didn't so I forgot to ask when this went into effect.

Stacey said It's an effect now. Yes, I just received the bill on it. It went up \$200.

Mayor O'Hare said Okay, well, let's discuss it now since we're here.

Stacey said but you can't vote on it.

Mayor O'Hare said No, we can't vote until next month. Right. Do we have to have a public hearing for it since we're increasing?

Stacey said I think you probably would.

Mayor O'Hare said Okay.

Stacey said To tell you the truth. I think I probably would have to.

Mayor O'Hare said Okay.

Stacey said We'll be having a public hearing next month anyway for the CDBG Grant.

Mayor O'Hare said CDBG we know back to back.

Rod, what are your thoughts?

Rod said you mean on the landfill?

Mayor O'Hare said Well, no, no, let's go. Let's go to the amount of garbage.

Because right now we're charging \$27 For one can.

Stacey said \$7 for the extra can.

Mayor O'Hare Okay, So with what we're paying them and what we're charging them, it's \$1 off. There's a \$1 difference. So.

Rod said so if we just do \$1 over like we did before, then we'd be \$30 and six, right?

Mayor O'Hare said well, I don't know if we're actually \$1 ahead right now.

Rod said Well, if they're gonna charge \$29, and we currently do \$27, right? We'd have to update to Thirty

Mayor O'Hare said All right, but we're, we're charging seven for the extra can, they're charging us five. Yeah, so we're gaining two there. But that's for the offset of all the other stuff. Rod said I don't know how many people have extras? I mean, there are so.

Mayor O'Hare said so go to \$30 a month with the extra can at seven.

Rod said Yeah. That'd be my thought.

Mayor O'Hare asked LuAnn.

LuAnn said if they raise it three, then we need to raise our three. So that's how I feel about it. We can't go in the hole, we can't do it for free.

Mayor O'Hare said Right?

LuAnn said we still have to, we still have to be.

Mayor O'Hare said that would be three, then we'd be raising it three from \$27 to \$30. Then they're raising it to three?

Stacey asked and the extra \$7?

Mayor O'Hare said Yeah.

LuAnn said Yeah, like extra can \$7. But I think the other three as well.

Mayor O'Hare Okay. So we'll put that on the agenda. We're gonna go to \$30 a month with \$7 for the extra can then.

Stacey said and that's per can. Because some have more. Mayor O'Hare said yeah, like we have three. So it's seven times 3. Yep. And then if we have to have a public hearing on it beforehand, just as Tammie, I think we do since we're increasing.

Stacey said I would say you probably would have to have one.

Mayor O'Hare said Yeah.

Rod asked do we have to make any mention of the commercial.

Stacey No, because we don't bill those. We don't have anything to do with the commercial cans at all.

Jayson takes care of those cans.

Mayor O'Hare said yeah, those ones there are between the businesses because it's only the business that has those big cans. I don't think any residential area has big cans.

Stacey said no.

Mayor O'Hare said Okay so that one's taken care of. And then on the landfill.

Rod said I like the idea of, you know, maybe, you know, doing these commercial cans.

Mayor O'Hare said yeah, I think it would save the town money than having the roll away out there. And then that can just be a waste of GreenWaste only? Well, that's what we decided already. It's just green waste and normal garbage that you would throw in your normal can.

LuAnn asked, so we will not be a transfer station. That's what we wanted to get away from.

Mayor O'Hare said Yeah. But they still want to charge us for not the green waste. They want to charge us for the roll-away. Can the state still want to charge? Because what they said was we are offering a service to the public.

Because I argued the fact with Mollie's having theirs. Well, that's for their business. And I said Well, the last time I looked, Snowville Town is an incorporated business. And part of our business is the community just like further business dumpster.

LuAnn said it is just the same with Mollie's outright dumpster.

Mayor O'Hare said yeah, it's the business. She said they said that's a business. So it's just that it is just for their business and getting the data means that they don't need a permit. But since we're doing it for the public, they're saying we have to have a permit for that even though I argued the fact that it's only for our residents, and we're a business it's just like Mollie's customers. You know, I was trying to try to argue the fact that we don't, we shouldn't have to pay it but he still said no. I've talked to the lady Gina in what is that place called? Stacey said Little Mountain?

Mayor O'Hare said Yeah. She says well we can help you out and we will charge I think 11 cents a ton. And we'll come and haul your stuff out for you and all this and instead of having Rupps do it we have to pay the \$500 whatever cost us per

container. They can do it but I don't know how many tons that thing holds. I have no idea.

LuAnn said it depends on what they put in here.

Mayor O'Hare said Yeah, but the thing is.

LuAnn said it might weigh heavy.

Mayor O'Hare Yeah, and if we only take normal waste and you know shouldn't be too heavy just normal trash so what I'll do because they wanted me to send them he called me last week the end of the day was last week yeah last week he called me and wanted me to let them know what we're planning on doing. So I'm gonna call him back with a question on these 300-gallon containers from our waste management that takes care of the town already if we would still have to have a permit for that so then we'll go from there.

Rod said Okay, sounds like a good plan.

Mayor O'Hare said okay.

So we had council members' seats next one. We still have a vacancy we had no, we posted it we had no interest so at this time we have the council members if you know anybody please approach them.

LuAnn said I have everybody that I can think of and nobody will do it.

Rod said What about the new places.

Mayor O'Hare, we haven't annexed them yet.

Is it better that we haven't asked him yet? You mean the cemetery stuff that was gonna be we've got to put that on.

Rod said shows where we got to go back to their building a house.

LuAnn said Brent would do it too. Is not illegal I told him to go through the border where they were rezoned and all the shit that comes with it.

Rod said, Jed Jones.

Stacey said Oh, Clark Hurd's property

Mayor O'Hare said So I must not have been here for that meeting.

Stacey said was it when Jed Jones was here?

Mayor O'Hare said Oh, yeah. Okay. So at the petition.

Rod said Yeah, they asked to be incorporated as I recall, we gave them the option they said yes.

Stacey said I haven't seen anything.

Mayor O'Hare said okay, well if you want to reach out to them to find out so we can get that moving.

LuAnn said But I would guess they won't be building their house anytime soon though. Because they're living on the ranch in the Ranch House now working for the girls.

Rod said Right. But if they have property they would still be viable for a Council Members seat correct? Right.

Mayor O'Hare said well, they have to live in a town for one year

LuAnn said he was just putting his cows there.

Rod said Okay.

Mayor O'Hare said so I think it's one year.

Jed said can you call and tell somebody to do it? Do give them the opposite.

LuAnn said Yeah, right.

AJ said It's like jury duty.

Mayor O'Hare said yeah, it is those that want to those that don't want to live in the town boundaries that's that's the part so we're gonna maybe if we get them to come in and get annexed then we can.

AJ, anyway.

AJ said this didn't come from me, but I bet you if somebody approached my dad you made me have to do it.

Mayor O'Hare said I was thinking about that. That was gonna talk to me the other day, but he drove by the house and I didn't want to go follow him.

AJ said I joked with him about it. He's never said no, I know he doesn't want to do the mayor thing. Now you may get here, maybe to do the council thing again.

All right, good. You didn't come for me I know.

Mayor O'Hare said it'll be a minute wait a minute so don't know

LuAnn said I tried to get my mom to and she said I'm 88 years old and I said so your body.

Mayor O'Hare said as long as you can talk and say I or NAY.

LuAnn said she is really smart and on the ball.

Mayor O'Hare said so just reach out to whoever if you guys can talk to whoever and if you got anybody interested Tammie on that one. If somebody is interested, they just need to come out for the application out here. And since it's not a vote we just discussed it at a town meeting and appointment right okay. LuAnn said we don't have a time frame, they don't have to be.

Mayor O'Hare said yeah it was posted and nobody applied so now it's open.

Tammie said Just yeah, whoever we can get.

Rod said, "Can we put that also in the water bill?"

So yeah, I know some people don't get the postings or read them, but they will read the water bill possibly.

Mayor O'Hare said real quick, Tammie. So we're going to be raising the land and the garbage since IDAWY away raised ours, we're going to raise ours. Do we have to have a public hearing for that? Or do we just have to put it on the agenda and vote on it? We do. Okay. Very good. So next month we'll have two of them. One after the other one for the CDBG and the one for the increase.

Mayor O'Hare said Appreciation dinner slash gifts. So it's that time of year again for the appreciation dinner or gift card. That's what I thought. So Town Council, what do you guys feel we should do this year? Last year we went to Maddox. LuAnn said we don't want to do that this year. It was \$108. And we didn't even have steaks, for my mom's birthday. I'm not really. I don't. I don't think we can afford to go there.

Did you suggest that?

I suggest we even have Tremonton. What place to go there? Heather said Isn't there a restaurant in Tremonton?

Tammie said The Grill?

Mayor O'Hare Yeah, we can't take them to your Burger King.

LuAnn said Nasty.

Rod said there are CJs and the Mexican place.

LuAnn said yeah, there's nothing in Tremonton you have to go out of town.

Mayor O'Hare said So do you guys want to have dinner? Or would you want to do gift cards for everybody?

And then they can do what they want to do and?

Or do you want to continue to do the dinner?

Well, a gift card to where it would just be a money gift card. It wouldn't be anywhere. In particular, it would just be a gift card that has.

LuAnn said like a Visa one well, I can't get them to work. So I don't want one.

Mayor O'Hare said It's not going to be something like that. Yeah. We don't want it to get one with a fee on it. So

Heather said I think you should get a card from the store.

Mayor O'Hare said yeah, I mean, we could do a Walmart gift card or something like that. Because everybody goes to Walmart.

LuAnn said that would be great.

Mayor O'Hare said If you don't want to do the dinner.

Heather asked What does Rod want to do?

Rod said Rod's very easy.

Stacey said Tammie said Amazon.

Rod said that is a good place to buy Amazon gift cards.

LuAnn said I know how to do those.

Mayor O'Hare said so we'll do Amazon gift cards this year, and the amount for each? What do we set aside for the dinners or whatever?

Stacey said so we usually have a husband and wife couple. So it's like \$50 bucks.

Mayor O'Hare said Okay.

LuAnn said that'd be great. If we have enough money, if we need money for something else, I'm good to bypass that.

Mayor O'Hare said so is \$50 for the two are \$25 each and \$25 each.

Heather said I'm good with cutting it.

Mayor O'Hare said so what if we just do the \$25 gift card for the actual person?
The employee for the town
and not the spouse?

Heather said Yeah.

LuAnn said yeah, we can be frugal this year.

Mayor O'Hare said since we don't, we're not gonna go out to the dinners.

LuAnn said since we don't know what's gonna happen?

Mayor O'Hare said okay, so everybody agrees that we'll do a \$25 gift card for employees only?

Or I should say yeah. of the town.

LuAnn asked can you buy anything for \$25 on Amazon?

Mayor O'Hare said yeah.

LuAnn said I've never gotten one thing for that.

Mayor O'Hare said I got a sleep machine for \$12.50. And we still use it. We bought that four years ago.

LuAnn said Yeah, really?

Mayor O'Hare said well, it's great. We got two of them. We run at night. Yeah.

Mayor O'Hare said so I need a motion for that?

LuAnn said I make a motion that we get \$25 gifts gift cards as a Christmas gift and thank you to Town Council Members.

Mayor O'Hare said for the employees it'd be all the employees. LuAnn stated all employees of the town.

Mayor O'Hare said LuAnn first, do I have a second?

Heather said second.

Mayor O'Hare said All in favor I? Okay Passed.

Mayor O'Hare said to Stacey \$25.00 gift cards for all.

Mayor O'Hare said Snow Plows drive Garrett Smith. So Garrett approached and said he wanted to work on a plow. He's in the process right now. And he should be pretty close to getting his CDL license. Has he finished that yet? Or is he still in? Is it still on it? Yeah. He said he would have it pretty quick. We reached out to the trust, they sent an email back saying that we did not necessarily have to have a CDL as long as they were trained on the equipment.

Did you get a different response?

Tammie said I did just kind of verbal.

Mayor O'Hare said From who I talk to, but with trust?

Tammie said and he said, well, and basically said the same thing.

Mayor O'Hare said Okay.

Tammie said he strongly encourages them to have a CDL. Mayor O'Hare said right.

Tammie said because they want them to be in compliance with the law before anything, you know, yeah.

Mayor O'Hare said that the law states, though, that they don't, you don't have to have a CDL.

Tammie said I don't say, see if they haven't you have that?

Mayor O'Hare we have it on and we haven't had an email, so we're safe there. And he is getting and just just to go on, you know, to have his back on this. He's the kid who drives trucks on the farm all the time. He knows how to drive semis. LuAnn said and he's awesome, he's a good kid.

Mayor O'Hare said and I did tell him I know I did give him when I got the email. I gave them the okay. I said you need to get up with AJ and have him go over it with you. He was out of town at that time. So I got with Tanner Hawkins. And then also Jed Daniels with the state, I think he's the one that actually got with Garrett. Is that correct? Do you know? You don't know. So I think Jed.

AJ said I don't think anybody's got it because he talked to me the other day.

Mayor O'Hare said so nobody has.

Davis said that he talked to AJ the other day.

AJ said I told Garrett that he'll figure it out.

Mayor O'Hare said so I told him as long as he got somebody to go over it with him. I know. He knows what he's doing. And he's familiar with it. I'm not worried about that. But just to be on the safe side, make sure you go over to somebody that's familiar with it, and have them sign off on you being familiar with it, and then you'll be good to go. So

okay, so he'll be helping Tanner. With that. We'll go ahead and remove that and then.

Mayor O'Hare said the snow removal for the sidewalks.

Keith is gone. Yeah.

So I told the people who bought the Thompson's house that since he left his tractor as part of the sale they had to do the sidewalks

LuAnn said they're good people.

Mayor O'Hare said anyway, we need to get somebody on that pretty quick.

Stacey said that it's posted.

Mayor O'Hare said It's posted. We haven't had any interest in it.

Stacey said well, I posted it Monday.

Mayor O'Hare said Monday. Okay, here Molly's so if anybody knows if anybody's got a small tractor it's not a lot of sidewalks it's in front of the park. Up here along Exit Seven parking and in front of the Motel and down by the School. So it just goes right on Main Street or Main streets on Stone Road and it's \$30 every time they do it's what we bumped, we bumped up the price for Keith and we're gonna leave it at that price because of fuel. So it'd be \$30, whenever it snows it needs to be done but it needs to get somebody if you guys know anybody that wants to do it. If you know anybody that wants to do that, let us Please let him tell him to come because we need to have somebody right away because if it starts snowing we have it's our responsibility. If somebody falls and hurts themselves out there we are going to be liable for it. So we'll have to make sure they have salt.

Stacey said I don't think he did either.

Mayor O'Hare said but we probably should have some salt form. What do you think would be better salt of that sand? AJ

For those sidewalks. Do you think that sand would be okay to sprinkle on there after you pushed it? The easier on it easier? Yeah. Then the salt right? Yeah. So we'll just whoever does it will tell them to grab sand from over here and give it a layer Okay.

Mayor O'Hare said annexation of the Town land and Curlew Drive and the Cemetery. So we have the cemetery as the town's property but it's not within the town limits.

But if we can get it annexed end, do you guys want to apply for annexation of the Cemetery and then the parcel over here which we have to annex this one because they're not going to put the tower up for Beehive until we get an annex, because they can't get the building permit for the tower.

And now it's not in town. It's the town's property, but it's in the county. So we would have to annex that parcel 10 acres well, the county would give it to them. But they've got to go through the process of requesting annexation. And that falls on us because we own the property. If we say, No, we're not going to annex it, then then the county will issue them, but then they gotta go through the county to do it. But I'm, I mean, my thoughts are, it's our property-wise, and it shouldn't be.

Tammie asked are you going to annex all the others?

Mayor O'Hare said well, no, no, we're just going to annex that parcel, and then the county, once I send the paperwork, and then the county's their responsibility to contact the people around the annexation parcel to notify them that this is being asked to be annexed into Snowville. And then those people have the right to come and say yes or no, that they don't I don't think so do you know, they get their two cents?

LuAnn said so there would be no reason not to, though, right?

Tammie said If you don't, there's different ways to work at it. I mean, who would rather be in the county if they didn't have to abide by the city ordinances?

Mayor O'Hare said and that's the biggest thing that people that are right on the border, they don't want to be part of Snowville because they don't want to have to follow.

Tammie said they have all of the conveniences that town members have like the garbage and water.

Mayor O'Hare said yeah, they and that's the other thing that we can talk about differently. Another thing. I personally think, personally, that if they're getting town resources, they should be town residents. So if they're getting water garbage from us, then they should be annexed, but we can't force anybody to do that. It's it's too late.

Jed said it came up as state law as well as the use to have to be contiguous, meaning that the annex partially had to touch part of Snowville the parcel yep, that's not the case anymore. You can annex what they call islands. So you don't even have to touch count limits anymore. Just a chunk over here.

Mayor O'Hare said that annexation takes away from them having to contact the people around that property, and then

Jed said they'd probably contact them and let them know that the property was petitioned to be annexed.

Mayor O'Hare said just as an FYI.

Jed said just as an FYI.

LuAnn asked even though they own the property, we could still do it without their permission.

Mayor O'Hare No, no, not their property.

Jed said it's probably noticed by everybody around them and says this parcel is up for annexation into Snowville Town city limits. But what does anybody care if a piece of Snowville property is annexed into town?

Mayor O'Hare said Yeah.

Jed said Okay to be no different than like the Smoots piece. It doesn't technically touch anything of Snowville.

Mayor O'Hare said Well, it does.

Jed said Oh, does.

Mayor O'Hare said it hits the tip of theirs and touches the tip of mine. It's the three tips that come together right. To the road. I think it's mine and yours, the Cemetery or the parcel over here? Yeah.

Jed said Technically they would be islands.

Mayor O'Hare said Yeah. Well, the Cemetery is just separated by a road, though. Right? Yeah. If it jumped over the road, the road wasn't there, then it'd be connected to down the limits. So, the town Council is on that. Your thoughts on annexing the Cemetery and then the 10 acres over here for the tower?

LuAnn asked and it doesn't make any difference, like on taxes on permissions on anything? It does nothing. It just stays the same. We just annex it in. But everything was basically the same.

Mayor O'Hare said I mean, I think we would because we pay taxes on that property. So I think we would get something back from the taxes right? For the town.

Jim Bealgey said you don't pay taxes on property.

Tammie said yeah, we don't.

Mayor O'Hare said we don't pay back on that property. Tammie said the Town doesn't pay on that property.

Mayor O'Hare said Oh, they don't.

LuAnn said we are exempt from that.

Mayor O'Hare said can you put my property under the town's name? Okay, so are there pros and cons then anybody have pros or cons on annexing the property?

LuAnn said I say whatever works best.

Mayor O'Hare asked Heather if she was ok with the annexation of the town's property. She said yes.

Mayor O'Hare said okay. So we will apply for an annexation for the two properties.

If I get a motion to do that,

Rod said I make a motion to annex to two properties that are noted

The Cemetery and Curlew Drive for the transmission towers. I have a second.

Heather second it.

All in favor.

Any opposed? Okay.

Mayor O'Hare said K- Rail for the fence between Mollie's and the Park. So, again, everybody knows that we have damaged the fence that was brand new that just got installed this year a truck over to Mollie's back into it. I have approached Mollie's twice now. I have not heard back from them, I'm going to approach them again, about the town coming in and putting K Rail up along the fence. Once it came out, the sort of cave key rule is a concrete barrier you'll see on the roads that kind of separates the lanes. But they're usually four feet wide and they come up like this. And then a tip comes up to a tip and it usually stands about three or four feet tall, smooth.

Rod said it is a cement barrier.

LuAnn asked How much of a drag?

Mayor O'Hare said straight down the fence line about four or five feet out. Most of the ones that are all trucks, all semi-trucks to park back there have to have a DLT bumper which sits below that. So if they back up that deal the bumper will hit that concrete barrier. And it'll stop them before they hit the fence.

LuAnn said or they could walk and it could knock.

Mayor O'Hare said Yeah, they pushed it. If they pushed it.

LuAnn said I've seen them. I've seen what they've done over to Flying J with the polls.

And you put the cement barriers in front of the post and they just hit the post and then they hit me they hit the cement barrier and then the policy limit.

Mayor O'Hare said I know so I will talk to them again to see if we still need to get him the approval because it's their property.

LuAnn asked how much will that cost the city.

Mayor O'Hare said I walked it off or measured it and it was going to be approximately nine to 10 Eight footers I think is what it was. I'm sorry 12 footers, and those run I think you can get them used for like \$150. James, do you remember when we talked about this when you were on the council? When we talked about those K- rails you said you saw some.

James Beagley said I saw him on KSL at that time, someone was giving them a bunch of white free. But they're not there now.

Mayor O'Hare said You didn't see a price though.

Carson Morgan looked it up and he said \$250 for a 12-footer.

Jed said there happens to be a whole bunch of them up by Exit Five if you can convince the state has a great big pile up there.

Mayor O'Hare said just storing them out there to get ready for next year for the construction.

Jed said they have been storing them out there for awhile now.

Mayor O'Hare said oh really that's and it's the State of the County. Okay.

Jed said they're just a big pile of them.

Mayor O'Hare said let me talk to Keith. You're talking about Keith. State Keith. Right. Yeah. We got to keep them.

AJ said I know Josh got it the other day.

Mayor O'Hare said Okay. Well, let me talk to Keith. Maybe, maybe Keith will let us store them over here. We can store 10 or 12 over here for him straight line.

And he can, you know, get permission from Mollie's. Okay, we'll do that. I'll check with Keith on that.

Mayor O'Hare said, Sergeant Eddington Welcome. How are you?

Good to see you. I don't have anything other than unless the council has questions about the stats for the month. I

mean, we've been.

We've arrested a few people this month who had been associated with the junkyards and different stuff issued some citations and patents on vehicles. So hopefully, I mean, it doesn't slow them down. They find another.

Stacey said I found you with the bumper dragging.

LuAnn said so when you've been overrun by the property and you know, the white truck, the white tent that they'd put up over here doesn't look like somebody's living in there they are.

Mayor O'Hare said yeah. And that was my next thing after he talked about it. Well, okay.

Sergeant Eddington said there were lots of people there.

LuAnn said Yeah. So we've noticed a lot of stuff going on.

Mayor O'Hare said this record or not, the place where the light enters. Are you going to be here till the end of the meeting? Yeah. Okay. I'll speak to you off the record.

Sergeant Eddington said yeah, I mean, there's lots of people going in now. They say they've got people cleaning that place up, but it looks like more jobs are being held there.

LuAn said we sit at my mom's house and just watch them hauling load after load after load.

Sergeant Eddington said I don't have anything unless the council has a question. The Council said No.

Mayor O'Hare said Good. I'll talk to you after the meeting.
Thank you.

Mayor O'Hare said Eric is not here. I thought Marianne was supposed to come.
Yeah. Is this what they sent? Right? They sent this here correct? The water thing.
So this is for our

Tammie said I don't understand. Did we ask them to do all this? Are we paying them? Why are they doing this?

Mayor O'Hare said Well, Will I was going to ask AJ.
Tammie said I questioned her in the email? I like why you need all this information from us.

She called and left me a message. I was out of town. She told me she was gonna call me last week and I never heard from her. So I have no idea.

LuAnn said they want to raise the fee?
AJ said Sweet.
LuAnn asked Do we need to raise the fee.

Tammie said No, I think we're doing fine with the way the rates are.
Mayor O'Hare said it doesn't have to do with our loan though.
Tammie said which one? This has nothing to do with our loan for the water.
Nothing to do with Forgrems I don't really understand.
Stacey said I don't understand either.
Tammie said That's why if they weren't asked to do this, and we don't like it, because I think they charge for all this stuff.
Stacey said they charge for everything they do.

AJ said Unless they're trying to get more revenue they can do some more projects that they want to do.

Tammie said she never responded because she wanted all of the information.
Mayor O'Hare said I'm wondering if this has to do with that. That study that Eric talked to me about he said they had to do it. And I wonder if that's what the study was.

Tammie said it wasn't that one that had to be done that you said last month was complete.

AJ said No, that was just for the Well.

Mayor O'Hare said Oh, yeah. Okay, that's the one that they were.

Stacey said this was an email today. That's why I forwarded it to you and then I pulled one for the council because I was like, I didn't know what it was either.

Tammie probably hasn't had time to look at it.

Tammie said I haven't sorry.

Rod said it says 2022.

Stacey said so I just made copies.

Mayor O'Hare said so Marine has prepared a few items regarding water rates and funding options for your information. And discussions this evening along with the CDBG public hearing.

Tammie said in this email she's talking or he's talking about Kurt being the person who they'll do all this for free for us with the Rural Water we pay them a fee and tell us that we don't need an engineer to help us do all this money so that's why.

Mayor O'Hare said so I will call Eric tomorrow.

Tammie said we need to find out more details about it.

LuAnn said they want to increase monthly payments.

AJ said Good. Looks like they don't want to increase the payment. They just want to give you less water.

LuAnn said \$36 out they want to increase it to \$36.05

Tammie said currently they want us to \$47 it says on the front page on the bottom it says the proposed rate is either between \$47 to \$50 a month. So that means raising at \$10 per base rate

Mayor O'Hare said well this is just an FYI. I don't think it's something we have to do right?

Tammie said but they charge us to do this service every month.

Mayor O'Hare said so this email from Marianne says please find attached information on rates. RW au does not have a list of water rates in the state, but they are willing to call around and by 2020 the average water rate was \$47.03 a

month Division of Drinking Water. Kurt Ludvigsen is the RW and representative who has worked with Snowville before Mike Morgan's time as Mayor. He would like to meet with Snowville and us together to go over Maggie's MHI and funding. So does that sound like something that we've done in the past since Mike was mayor, which was in 2003?

AJ said the last change of water rates was when I sat down with Kurt Lovings. That was before it was even owned by the town when it was still a private water company.

Mayor O'Hare asked so when your dad was the mayor.

AJ said it could have been.

Mayor O'Hare said okay. But I'm not gonna say that we shouldn't look at the rates. I don't know where we're at. I know water use is way down here. We know we're not near the water, right that we used to be. So I don't know where that books are where we're at. But I'm sure our revenues are down. So I don't know if we have a lot.

LuAnn said we had a lot of storms this summer too.

AJ said so nobody was there long. I mean, you drive up the road and see nobody waters their lawn anymore.

water use. So you're kind of cutting your own throat in my opinion, if you don't want to water the lawn, you're cutting your own throat because somehow that revenue has to come in one way or another. So whether you get your waste to raise water rates to get back to where the revenue was, or your water, your lawn is kind of a two edged sword. Sure, sure.

So it's probably something we ought to look at. I'm not saying we have to do anything, but my opinion is we ought to look at it and see where the numbers are in what we need to do and if anything.

Tammie said okay, and this is making more sense as I read this, so he's saying that he would like to meet with us and so we'll be together because they're probably not wanting to help us get funding to make sense of what they're wanting to do for the water.

Mayor O'Hare said So let's set up a meeting with them and then we can find out what it is.

Tammie said yeah, and then proceeded from that point.

Mayor O'Hare said Okay.

AJ said It's like everything I mean the cost of everything's going up, it's costing the town more to make a gallon of pump a gallon of water. So I don't think it's a bad idea to look at it.

Tammis said we could pull reports and see.

AJ said Hours definitely have not gone down.

Mayor O'Hare said Okay. So do you want to get up with this, this guy to find out when? When would they like to do a meeting after the first of the year? Whoever wants to meet and that email?

Mayor O'Hare, do you want to call it?

AJ said so does the engineer want to meet with Kurt Yeah, then I would just get Forsgren to line it up with Kurt if they want to be involved in it. And do it all at the same time?

Because I can call Kurt but I have no idea what the engineers want to do. So I'll be like, we want me to do but you got to call them so.

Tammie said that's true.

Mayor O'Hare said yeah, get up with Eric then. You just go out there after the first of the year. Okay.

Mayor O'Hare said Okay. Fire Department Chief, same old same. has been busy. Haven't had much fire. But we've been in wreck accidents like crazy. They find the cats. Yeah, good. It was quite the ordeal when we found them.

No, we actually did. She found one of them then we found the other but we had to extricate the cat from the car.

Mayor O'Hare asked Jaws of Life.

Jed said No, we didn't. So instead Trudy took care of the cats. So other than that, the County's still working on some communication issues and problems we're having.

Mayor O'Hare said you go ahead? Sorry, let me know.

Jed said I've supplied them with a couple of different options that are supposed to be looking at another guy from Teton communications to United county us who was working through a couple of systems to see what they could do, as well as trying to get us a radio for the ambulance and crash truck to communicate with Oneida County. But other than that, we're just.

Mayor O'Hare asked did you ever get your \$5,000 radio?

Jed said that on Shabbat we're sitting at the county offices right now. There's only a certain amount of numbers that can be assigned to radios in the state. Right now the state is out of numbers.

Mayor O'Hare asked so why did they sell your radio? That doesn't work?

Jed said That's a good question.

LuAnn said They could just go to the next.

Mayor O'Hare said It's like Frontier out here. They've only got a certain amount of ports, there is no next number.

Jed said Splitting that bandwidth they call it. So instead of running 800 megahertz and 700 makers, and I will double the amount of radio but they're still waiting on them.

Mayor O'Hare asked if you could ask the state to give us our \$5,000 back so we can put it in our bank account, to collect the interest. I mean.

Jed said it's been months, it's a pain in the butt. At least the radios are there.

We're not the only ones the county got a grant through the BLM.

Kind of greater Property Management makes up 35 of those \$5,000 radios sitting in the same location.

Mayor O'Hare said to make sure they know we get the number first.

LuAnn asked so whose idea wasn't that these radios were needed?"

Jed said their state was actually mandated.

LuAnn said oh, imagine that.

Mayor O'Hare said It's the state. It's the state. I'm just telling you it's a bunch of crap.

Jed said the government at its finest in the foyer.

So even if, like, one of the last numbers in the state that was assigned was the number that went to our ambulance, believe it or not. So the county was trying to figure out if they had any radios that had been lost or not in service that they could reassign some numbers for. So they're still trying to get that all figured out.

Tammie asked if would there be some other radios that are still around here.

Jed said yeah, surely, they're only the 800 megahertz radios that are assigned to those numbers.

Mayor O'Hare asked but not having the but not having the radio right now has been tampered with anything?

Jed said yes and no.

Mayor O'Hare said okay, so it has caused a little issue.

Jed said Yep. So the 800 megahertz radios that we have to use right now to communicate with dispatch and Brigham City. There's a hardwired one in the ambulance. There is a handheld that sits in the ambulance. And there's my that's it.

Mayor O'Hare said and the crash truck does not have the trash truck does not have on. Yeah, I know the crash truck doesn't have one, it and that's hard when you're, when you're on scene, and you're down the block down the road, like when I was going out. And I'm half a mile from the crash scene, getting traffic over, and not being able to communicate with you guys when there are dead spots on the phone sometimes doesn't work.

Jed said it has hampered us with a few issues, but when we can get them figured out sooner rather than later.

Mayor O'Hare said So the ambulance doesn't have one.

Jed said the ambulance has a hardwire card wire and a handheld that sits in that ambulance in case you have to get out of the ambulance like carrying an extrication or doing patient care on the side of the road. So sometimes.

Mayor O'Hare said so if you were on scene if you were on scene, can that handheld go into the crash truck? And then that way they can communicate because you're with the ambulance.

Dave said but then somebody has to be inside the ambulance. Like if all of your personnel were outside of the ambulance.

Mayor O'Hare said Well, if you got Jed he's got his radio. I'm not there every time.

LuAnn asked how many go on the ambulance.

Jed said as many as we can get.

LuAnn said Oh, really?

Mayor O'Hare said It's like one of those clown cars, you know? Open it up. And just start.

Jed said It depends on whose home really.

Mayor O'Hare said Yeah.

Jed said It just depends on what we need. Who's around and what kind of response is needed sure the one the other day up in Idaho. You guys used everybody that was there.

And part of Burley and part of Malta.

Mayor O'Hare asked Is that the one on highway 30?

Jed said no I-84 they shut the Interstate down landed a bird and extricated.
Dave said but I don't think we transported anyone.

Tammie said but then you paid 10 people.

Mayor O'Hare asked to wait a minute, we don't get paid for going on that call and rendering treatment until the bird came. Tammie said only when transporting.

Mayor O'Hare asked Why? aren't we billing?

Jed said it's a state law.

Mayor O'Hare said a State law of course.

Tammie said we could try to bill for a non-transport.

Mayor O'Hare said but we're rendering. You guys went on scene and rendered aid until that bird got there. Correct. Tremonton came Oh, the bird was already there. Burley had the bird coming. Oh, so you guys didn't do anything then.

Dave said but yeah, I mean, it generates were like Tammie said, the ambulance leaves here. We paid EMT. No, I know for being out there.

Tammie said the other ones compensate for?

Dave said yeah. It's one of those deals.

Mayor O'Hare said That the ambulance crew worked more as fire extrication then.

Carson No, no, it was all hands on deck.

Mayor O'Hare said well, I know that I'm trying to figure out where the billing is for the fire department bill. Does the fire department bill that day?

LuAnn said they were just volunteers from Snowville. Yep.

Dave said but it is a sad truth that in the whole health care industry, there's a lot of those that pay plenty to make up for all of the other calls that you don't get.

Tammie said for example, and I think we've talked about this before but on a medical call. If that patient has Medicare, and you go to that call you and then they decide not to be transported. You cannot build a non-transport to a Medicare patient or a Medicaid patient.

Mayor O'Hare said Of course.

Sergeant Eddington said if Lifeline comes and they don't transport they don't get paid and they come from Salt Lake.

Mayor O'Hare said they don't get reimbursed from the State and don't get reimbursed from the State really?

Sergeant Eddington said zero money.

Dave said we've done that and had an ambulance or to Tremonton then we'll have a helicopter land there at Tremonton and then it's decided they don't need to go on the helicopter so they just fly back. It doesn't cost anyone anything that any way they don't really seem like they'd like to get out and fly. But yeah, but flying covers that cost. You know, it's not getting billed.

Mayor O'Hare said Interesting so that I know that.

Jed said even life-flight or classic, say we have somebody stuck out on the mountain, they'll come flying out, use a hoist to go down and pick that guy on moving over to a ground ambulance, drop that patient off and take off. There's no charge on the patient.

Mayor O'Hare said so I'm gonna get charged if you get on the helicopter and take the flight. But you get charged 40 grand and don't so they pay for all the other ones. So the moral of the story is right, your moral of the story is to sign your name refused medical.

Okay, all joking aside, glad everybody's okay, though. Everybody's fine. Crews everybody. Good. Okay. It's been busy for the crew, I think they were looking in the month of December already. We're at 12 calls.

Mayor O'Hare said yeah my pager has been going off every day. So pretty much. Okay, you got anything else for us chief?

Jed said oh, just thanked the town council for the help of the Fire Department for the Christmas party.

LuAnn said Thank you, however, well, yeah.

To help us.

Jed said we packed the Fire Station.

Mayor O'Hare said we're actually going to talk about that down here at the bottom.

Jed said if you need any more, we're going to have to clean up the other station might take a while though.

Mayor O'Hare said President Smith from EMS.

Dave said so we've got some EMT classes going on. We've got Garrett and Carson enrolled in class starting here on January 8.

Did you guys get confirmation that you're registered? Right. Yep.

So yeah, we've got that taken care of.

Stacey said good cuz I called and asked what we needed on that check. And there will be a few more fees with them. We paid the tuition, but then there's like a state fee, of course, \$5, and then the national EMT fee of \$136. And so we'll probably get them with Tammie and just run that on the card. Because they'll have to set up their account.

Stacey asked Carson to pay for it.

Dave asked if was from your class before. Carson said yeah, so she's gonna have to do it again.

Stacey said we need to reimburse you.

Dave said that was part of what we're planning on doing.

Jed said Pass then they will reimburse you.

Mayor O'Hare said he would pass.

Dave said and then we've got an advanced class that Ilesha Velasco was signing up for.

Mayor O'Hare said Okay.

Dave said this is one through Salt Lake Community College like we've done before, and there's been a little misunderstanding, I don't know, we haven't got a set answer. Because of the Salt Lake Community College, it says there's tuition assistance available. And like the one that McKenzie took, it paid for that, because there was a grant that was set up for rural EMTs. I don't know if this one's gonna go that way or not. But we've got Ilesha willing to take it. If we cover the cost, it's \$1,100 tuition for her. And then they'll have the same type of fees, the \$45 on the state two licenses will be six. So I'd like to set it up. We'll try to get it through.

I don't know if there is a grant. But if there is a grant that'll cover that. We'll try to get it through that way. But if I'd like to just go ahead.

Mayor O'Hare said the total would be \$1,300.

Dave said yeah, the \$1,381 is what I came up with, with the total because there's a psychomotor test for \$100 a state license fee for \$45 on the national our EMT is \$136 and then that tuition is \$1100. So that's 1381 though we'd be doing there for her to do that class and be an advanced.

Tammie said we will need a motion.

Mayor O'Hare said we have to do that because it's over five hundred.

Dave said if we're going to if that's the way it's gonna go. We'll probably have to get it checked going in early in January.

Mayor O'Hare said So you want to go ahead and finish with your FirstNet

Dave said FirstNet. I got a call back saying they have approved us. But the only pricing that they sent me was just for all the different tablets that they offer. It didn't give the per month costs. So we could compare it to what we're paying already with Verizon, so I gotta get back with them. They gotta send us a better pricing to understand because the only pricing sheet they sent us is the cost of the different style tablets, iPads, cost of the service. But yeah, because I mean, it makes sense to compare. I mean, we know what we're paying monthly to Verizon.

Mayor O'Hare asked if FirstNet was going to take over Verizon, right?

Dave said Yeah, that was our plan if First Net isn't the way to go. We'll just stick with Verizon and get us a tablet. Yeah, do away with the phone and just upgrade to a tablet with Verizon. So either way, our and the end result will be the same.

We were just trying to see if the First Net was a better one. Yeah, I mean, it's supposed to be a coverage that will put priority for you guys, First responders.

Stacey said they are kind of slow, aren't they?

Dave said yeah. So anyway, I'll follow up with them and hopefully have something next month so we can decide which one we want to go with.

I think that's everything. Okay.

So we have for town council members, we have Ilesha Velasco, who's going to be going to training for intermediate EMT class. The cost as president Smith indicated a total would be \$1,381. We will need to get a motion to approve.

Up to \$1,500, just in case there's some extra fees. Is that okay, Tammie? Or do we have to vote on the actual amount? Tammie said. Can we say \$1,500? In case there's extra? Mayor O'Hare said, okay. It's up to \$1,500.

LuAnn made a motion to approve the cost for Ilesha Velasco to train in the EMT Intermediate EMT class for \$1,500. fee if needed. And do I have a second?

Rod Second. All in favor.

Aye. All opposed, passed.

Mayor O'Hare said and just so everybody's aware of the record, if the grant does come in, and the grant will go towards the town fund for that? Well, get that figured out before we have to write a check. Oh, well, you Okay, Very well.

Okay. Yeah, ya, clerk Snowville Stacey, Tammie for me, all I have is so far I've started the application for the CDBG. I have the first public hearing notice, I'll type that and send it to Brian to get his approval. He said everything was great. I posted it on the public notice website already. It's already there. So plenty of time. So they shouldn't have said that but it hasn't been there long enough. And then, as soon as I get approval for it, it'd be posted in the leader. I'm gonna send that to Brian and make sure that we're all good there. I'm gonna have it run for two weeks. So we're covered.

Mayor O'Hare asked Is this the same guy that told us we were good last year when we weren't good? And the year before?

Is there anybody else that can look over it to make sure it's, He's the guy that we go through?

He's not very good.

LuAnn said Somebody else to just test.

Mayor O'Hare said I mean, two years now, he said, we were good. And then it came back that we weren't qualified for it because we weren't good. So if we don't know the guy. So I just know what's happened in the last few years of emails.

Tammie said I think he's rooting for us because he asked me if I have the forms to start getting bids for the project. And he asked if I needed any requests for bid templates. And so I think we're looking like it's gonna be good.

LuAnn said this State guy whatever. What's his name that keeps contacting me? He's really rooting for us to contact nobody.

Mayor O'Hare said because that's the guy with the bridge. Yeah, well, of course, he's rooting for you because he wants the money.

LuAnn said But we want the bridge.

Tammie said So I am going to be, unfortunately, trying to figure out exactly how much we need because now we can apply for more than \$200 if we need it. I don't know.

Eight \$800,000.

Mayor O'Hare said so let's apply for all of it. Because it'd be really nice to get the County to do this Hallows. Potter Hallows, whatever that flooded.

Tammie said I think you can only do one project though.

LuAnn asked what happened to your Mayor thing, where did go?

Mayor O'Hare said I've got it doesn't start till next year. At the next quarterly meeting, I gotta do the application. We need to get me in, you need to get together to do that.

Tammie said so I will get with Eric too and find out get some
It has been two years now and we need to update. So that, on that grant, we tell them how much we need for what budget or just how much we need to do projects. What's more, is the money's budget for the project. LuAnn asked and we get that from the State, right?

Tammie said well, Eric, talked to me last time because he had it all lined out as to and it's probably more now. LuAnn said Yeah, it's kinda so we got to pay him again to do that.

Tammie said I don't think we should. I mean, I think you will probably have to pay a sum but not I think he's already done the work like it's just we need to decide how much it's increased.

LuAnn asked how will you find that out?

Tammie said Eric would know. Yeah, so I, that's what I have. Okay, thank you. Fingers crossed. Yes.

So we're gonna look CBD grants are gonna go towards that bridge. Okay. Snowville treasure. So all I have, again, is like I'm bringing up the water again, I fight with the same people every month.

You and I've talked. I've talked about this several times. Yeah. So I pulled up some Tremonton papers to see, like, I can't remember. Is it 60 days that they turned it off?

Tammie said No. 30 days, 30 days? I haven't paid for 30 days. And it's shut off then? Because I couldn't actually find it. Mayor O'Hare said so last year, I think it was last year. We the town council, you're voted on for 60 days, is that correct? We do 60. We have a resolution in effect for 60 days. But we have people over 60 days old. I mean, we've got we've got the rule in there.

LuAnn said It's there. So are there extenuating circumstances wherever they just didn't meet? That is a good question.

Mayor O'Hare said the thing is, if they would call Stacey on Monday, and make an attempt to at least notify us, Hey, I'm having a hard time right now. That's done. We're good. If they call us if they call us and make an effort to say, Hey, I can't pay it for this reason, but I can give you \$2 In two weeks. Okay, you made an effort to reach out we're going to work with, but when they're not when they're not doing it, we need to do 61 days. Turn it off.

Tammies said Yeah. So for a current, they have to pay that \$37 Yeah, plus \$2 A month extra or whatever, you know, yeah.

Mayor O'Hare said as long as you're making an effort to try to get it, the ones that are not calling or not making contact and ignoring you just have AJ.

Stacey said I sent the letters out and they just totally, maybe they'll come and I was given the benefit of the doubt.

AJ said I guarantee you just send me over there, they will come and pay.

Mayor O'Hare said that's what we need to start doing on day 61. So well, it's up to the town council. I mean, that's what that's what our rules say. And that's what it is. 61 days. So after 30 days, they're 30 days late. You give them a late notice, right? Okay.

LuAnn said they know it's coming.

Mayor O'Hare said when they hit, should we give them another notice when it's so.

Tammie asked, didn't we used to like to get a two-week notice, like You pay it on the 15th of the month? Then Alan would post something on their door?

Stacey said well, yeah.

Tammies said like it's 60 days And then there'll be a notice your water will be shut off tomorrow. Do you have it?

Mayor O'Hare said so let's, that's what we do. That's what we do from now on. If they haven't reached out to you Stacey and made and made an effort. But if we don't do it, they're gonna just keep thinking like.

LuAnn said I remember that people out two years, and there was no way that they could come up with \$10,000 or whatever it was, you know what I mean? So they ended up excusing it and we can't let that get to know.

Stacey said you can't excuse it.

Mayor O'Hare said so if there's any, let's wait till after Christmas. You want to wait. Let's wait till the first year.

If you want to work Christmassy

AJ said Just tell me if it needs to be turned off, turn it off.

It is if the power company you are paying it.

Mayor O'Hare said So yeah, after January 1, then if there's anybody than glad to do what you got to do to.

Stacey said the ordinance

Mayor O'Hare said per town ordinance. Yeah. There are the ordinances there.

Stacey said Well, there's one and she reached out to me like, I mean, there's money in there. And I was totally surprised that it was there today, because I looked, but basically, she made it to reach out to you, you know.

Mayor O'Hare said So it's as long as they do that, then you can work with them to pay it and get it paid off. But as soon as they start slipping again, if they don't, if they slip them, they don't and then they don't contact you. Turn them off.

Stacey said Okay.

Anything else?

AJ, nothing.

Mayor O'hare said First, I have a question for you. I don't know. I mean, it has nothing to do with our water. It has to do with water. We're rainwater, but maybe you. So the bridge down here that the state wants us to spend the \$3.6 million to do okay because that's for rain. runoff? Correct.

AJ said That's why that was irrigation. Ditch. Technically.

Mayor O'Hare said it's an irrigation ditch.

AJ said Yeah, but the water's purpose is for irrigation. So there's a designated amount of water that has to go down that creek.

Mayor O'Hare said Okay, Do you know the volume of water that's supposed to go through there?

Dave said 8.3 CFS.

Mayor O'Hare said Okay. What about do we know how much water goes through over here at this hollow? That's what has to go through the hollow. So the water that's going through there has to go through there as well? AJ said Yes, yeah.

Mayor O'Hare said Well, it's the same. Okay, that's

AJ said no, no the one that flooded this year that we were just run off water.

Mayor O'Hare said so that's okay. That's what I want to find out.

AJ said I thought referring to the culvert down in the dairy and the creek.

Mayor O'Hare said No, no, the one that flooded.

AJ said but that's the amount of water at that culvert, by the dairy is that eight-point, whatever? There's not that much gonna make it this far. But that's technically how much is supposed to be at that cover, that Potter Hollow is runoff.

Mayor O'Hare said Okay. That's what I was wondering if that was part of that. Because they're saying this one here in their State saying we have to have a \$3.6 million bridge and the County is telling me over here, we could do this for under \$200,000 Creek.

AJ said you go anywhere up through Idaho. They don't even have bridges across on I- 84 through the big canals that are running through that Magic Valley area. They've got either a concert. Yeah. I just don't understand why they're.

LuAnn said the guys that came and inspected it, remember we're out there with him. And he said, Why can't we just do the concrete thing? And I said, Exactly. That's exactly what we want to do. And he said it would not even come close to what they're calling well, not when we can get the county to do it. The counties already told me when I told them the state we have to follow state regulations on the bridge because it's that road.

AJ said I would just bring up how I-84 through the Magic Valley doesn't have bridges.

Tammie said but that's Idaho, and it's different.

AJ said Yeah, well, yeah, I think that's it, there's some point on 84.

Mayor O'Hare said there's concrete ones going down through Tremonton.

Because we can get two of those by their red barn. So that's the irrigation ditch.

AJ said That bridge goes over if you want to label it correctly. Dave, what would you say without water that runs through that as it is? irrigation water that we have running through all these ditches.

Dave said up here that what we get from our terminology would be seasonal. Do we have irrigation or a year-round? Mayor O'Hare asked who owns that who owns that ditch water than the US. That's Curlew water runoff or Yeah, it's AJ said technically the water.

Dave said well, I know it's a reservoir because there's a water user right? That gets out irrigation water, but you can't deal with the creek without getting the Army Corps engineers involved because it's a year-round stream, even though it's dead ends down there. It still falls under a stream. That's underwater.

AJ said to leave us because of the exhausted state lines.

Mayor O'Hare said Okay? Yeah, well, so they're tackling the natural flow of the water spring,

Mayor O'Hare so nobody owns it?

Dave said so you can't treat it like a canal, you know, if it was, if it was truly a canal owned by the Canal Company or the irrigation district, then it could fall under different things. But it's a, it's encrypted. It's got its nature that acts like a canal.

LuAnn said that the people and the people who own the water rights have X amount of inches or feet per year that they should get per year for their irrigation rights once they have stock rights.

Rod said and you have a stock price.

LuAnn said Right, right.

Mayor O'Hare said there are too many Rights out here.

AJ said I understand there's only a handful or less than actually have a stock right?

Mayor O'Hare said So it's not, it's considered a natural Creek, creek, or whatever you want to call it. But the irrigation company uses it as irrigation water?

Dave said the farm out there is the end user of it; they own irrigation, right? The irrigation company delivers it through the creek.

Mayor O'Hare said Okay. So let me ask you this, is there anybody associated with that Creek that should be liable for helping out with the payment of that bridge?

(Someone said) Carl Nyquist?

Mayor O'Hare said to get around it. Is there anybody besides us being responsible for having to pay for it? Because it's a state highway?

Dave said Yeah, I don't think you'd have any, you know, any recourse.

Mayor O'Hare said That's what I've. That's kind of what I was getting at.

LuAnn said he has endless pockets and he would just sue us So we don't want to do that.

Jed said \$100,000 in legal fees.

Mayor O'Hare well, no, it wouldn't be us. It'd be the state. We just point him in the right direction. You know. Okay.

Anything more AJ?

Mayor O'Hare asked if Rod had anything for tonight.

Rod said Not tonight, Thank you.

Mayor O'Hare asked LuAnn do you have anything for tonight? Mayor O'Hare said the bridge, you had the meeting with them.

That was last month. Yeah. Only it's still number four.

LuAnn said That's it.

Mayor O'Hare said Heather, an update on the Christmas party.

Heather said it went well, Jed is like a total superhero. I gotta say. I just love him to death.

Mayor O'Hare said I heard all good things about you, Jed. I appreciate that.

LuAnn said How many kids were there?

Stacey said I don't know I didn't count, a lot.

Tammie asked how the coloring contest worked out.

Heather said that was kind of a mess with too many responses.

Heather said Yeah, I would suggest to many 20. So it went on and on and on. At least maybe I'm thinking the sponsors could do it, but only when giving a gift per sponsor.

LuAnn said so we had 20 sponsors with six gifts. So it took forever so that was too many.

Stacey said and there were some kids that said that they didn't get their prizes, other prizes were bigger than some of the other prizes. I'm serious, you're damned if you do and damned if you don't, then this has any coloring contest winners but this I have a whole bunch, and oh my gosh.

Heather said so it just needs to be organized, more it was my first year doing the sponsor thing.

LuAnn said well and it is what it is if you color your picture like crap, you're not going to get a prize.

Stacey said right and that's what happened.

Mayor O'Hare said 20 sponsors.

LuAnn said we had 20 sponsors,

Mayor O'Hare, who were the sponsors?

LuAnn said they were everybody wanted to do it.

Heather said maybe we could have him help participate as a sponsor in other ways.

Mayor O'Hare said, "Maybe next time if you're gonna have that many we will use the other building and put the sponsors at tables and have them do their own thing.

LuAnn said we can get to technically you guys we don't need to be technical. The coloring contest is what it is. We don't need to get into this.

Heather said we will definitely change something next year.

LuAnn said Carloyn posted it on Facebook, so everybody that wanted to come contacted her and we were shocked, 20 different sponsors.

Tammie said Awesome.

LuAnn said they were from Holbrook, Stone everywhere.

Heather said Jed was rushing to get more tables and chairs, it was crazy.

Mayor O'Hare said well, we appreciate Jed you really did a lot to make it available.

Jed said I didn't believe that we could put that many people in the fire station. Holy Cow. It was like shoulder to shoulder.

Mayor O'Hare said we do appreciate the use of the Fire department too. And the EMS.

Stacey said Santa was cute too.

Heather said last year was really bad here. You couldn't even sit people.

Tammie asked did you book Santa again?

Heather said I did.

Mayor O'Hare said wait did you book him for what day?

Heather said I haven't done a day yet.

Mayor O'Hare said so let's do that.

LuAnn said Well, he was gonna get a hold of her because he wants to work with Tremonton.

Heather said Yeah. So Tremonton was trying to take our date. And he's like, No, Mayor O'Hare said well, then let's give them a date. Now that way, we say this is our date. We don't have to wait for Tremonton.

Heather said so I just wanted to find out a date.

Mayor O'Hare said so next year. We have Saturday, the seventh? Saturday, the 14th. And Saturday, the 21st.

LuAnn said to do the early one, the seventh.

Mayor O'Hare said on December 7, Okay, so we're gonna do the 2024 Christmas party.

Heather said I just got to confirm it with him

Mayor O'Hare said on Saturday, December 7. and you can confirm it tomorrow or whenever you can and just let everybody know that you've got it confirmed.

Okay, anything Heather?

Mayor O'Hare said All right. Public comment is going to be opened up now for anybody that has anything they need to say or have any concerns or comments.

Okay, we will go ahead and pass on that. Acceptance of the expenses. I have a question. So Frontier, we still have a Frontier telephone.

Stacey said Yeah,

Mayor O'Hare said I thought we were gonna go over to Beehive when we got the internet.

Stacey said Beehive phone?

Mayor O'Hare said Yeah, Beehive does telephone, Internet. television. They do it all.

Stacey said every time I try to call them I never get them to answer.

Mayor O'Hare said Excuse me?

Tammie said is it an internet phone?

Mayor O'Hare said It's a landline. You can have a ported-over If this is the phone number we have. It might be cheaper because I'm just looking here at this one. This one's \$293 a month.

Tammie said over there they have it for the Fire Department we have to have a landline for the pagers.

Mayor O'Hare asked Do we need a phone over there at the fire department?

Jed said I thought it was just that one was disconnected.

Stacey said that one is disconnected.

Mayor O'Hare said so we just have a phone for the office and for the pager.

Stacey said I think.

Mayor O'Hare said I would check with Beehive because you might be able to incorporate that into a package and it might save a little bit of money.

Stacey said If I can get a hold of them.

Tammie said it meant an internet-based phone too.

Mayor O'Hare said it's probably going to go through the fiber. I mean, it's gonna go through that. Okay, just wondering.

Stacey asked can they do the pagers for that too.

Jed said we just have if they change the phone number, we'll just have to update dispatch with the phone number.

Stacey said Oh, okay.

Mayor O'Hare said but I think they can use the same number because you're gonna kill it with Frontier and they can just probably port it over like I did a cell phone.

Stacey said I was supposed to disconnect and then I can't remember.

Jed said it was the fire department one.

Stacey said but there's another one that I'm supposed to disconnect.

Mayor O'Hare said Okay, everybody was given the expenses. Your guy's name was actually emailed. Thank you Stacey for the email in it. We appreciate that everyone should have been able to get to see that before we got here tonight.

Everybody signed it. Does anybody have any questions?

So can I get a motion to accept the expenses?

LuAnn said I made a motion that we accept the expenses. second Rod second
