## RESOLUTION # 14-44 C

### A RESOLUTION AMENDING THE SANDY CITY FEE SCHEDULE FOR FISCAL YEAR 2014-15

**BE IT KNOWN AND REMEMBERED** that the City Council of Sandy City, State of Utah, finds and determines as follows.

1. In conformance with the budgetary procedures followed by Sandy City, the City Council has levied certain fees and charges within its boundaries for fiscal year 2014-15; and
2. These fees are being amended as follows:

#### Impact Fees: Parks and Recreation, Fire, Police
