## **Discussion Items**

- Camera Requirement Linking cameras to attendance may be a violation of Free and Appropriate Public Education (FAPE) according to school attorney. School should be careful about instituting policies beyond simply having cameras on.
  - Clear expectations in handbooks and/or policies.
     School should have a procedure in place for students to be exempted from requirement on case-by-case basis.
  - Carefully document the reason why a student do not want be on camera.
     Ensuring a conducive learning enjoinment for students who opt out.
     Recommendation
  - Move students who violate camera expectation into an alternative setting.
  - In an alternative setting have reminders regarding expectations such a slide reminding students of expectation.
  - Provide up to two warning for violators.
  - Upon third warning links to disciplinary offense (Level 2).
     Third warning would be Level 3 disciplinary offense.
     Parent-Teacher Conference with school administration In-School-Suspension

- **Out-of-School Suspension**
- Discussion fear that if student is moved into a breakout room that the student would still not have access to the lesson and be actively engaged. We can show engagement in alternative ways like ClassKick, responses on the mic, and chat
- Quality of instruction, in time learning and execution of the consequences
- Clear understanding is needed from families as to WHY cameras are not on so that we can help families be in line with the expectations
- Question raised as to why USU would advise cameras when this could possibly be a violation of FAPE
- Criteria and Expectations document is a 1 pager of summarized information for parents that is currently in our handbook. This is just an "at a glance document"
- "Cameras on" to be added in disciplinary section of student-parent handbook.
- CAU will discuss alternative ways of showing engagement during live class with USU using solid evidence.
