A RESOLUTION BY THE OREM CITY PLANNING COMMISSION RECOMMENDING THE CITY COUNCIL APPROVE THE CONDITIONAL USE PERMIT OF A FAMILY RECREATION EXERCISE BUILDING LOCATED AT 1014 NORTH 1280 EAST IN THE PD18 ZONE.

- 2. 




