

# ORDINANCE 14-05

## AMENDMENT TO CITY'S ZONING MAP – CHANGE OF ZONING Parcel #13-012-0069

### From Residential Moderate (RM) to Agriculture (A)

**WHEREAS**, the property owners of Parcel #13-012-0069 have made application for change of zoning of said parcels from current Residential Moderate (RM) to Agriculture (A) Zone; and

**WHEREAS**, on 24 April 2014, the Planning Commission held a public hearing to consider the application for change of zoning and recommended approval of the change of zoning; and

**WHEREAS**, on 10 June 2014, the City Council held a public hearing to consider the application for change of zoning; and

**WHEREAS**, the City Council determined that this change of zoning conforms with the General Plan and it is in the best interest of the City to approve this change of zoning.

**BE IT THEREFORE ORDAINED** by the South Weber City Council that the Zoning Map referred to in section 10-1-5 is amended as follows:

**Section I.** The following portion of real property is hereby rezoned from the present **Residential Moderate (RM) Zone to Agriculture (A) Zone**
