HB15 Criminal Code Recodification and Cross References

Motion: Brett Peterson motions for the commission to support HB15. Tom Ross seconds the motion. The motion passes unanimously.

HB21 Criminal Accounts Receivable Amendments

Motion: Richard Mauro motions for the commission to support HB21. Ryan Robinson seconds the motion. The motion passes unanimously.

HB68 Firearm Modifications

The commission agrees this is dangerous conduct requiring intensive intervention. Some commission members raised concerns related to 1) mandatory provisions removing discretion from courts; 2) value of sentencing increase as a deterrent.

Motion: Chief Craig Black motions for the commission to support HB68. Craig Barlow seconds the motion. The motion passes.

HB110 Sex and Kidnap Offender Registry Amendments

Motion: Richard Mauro motions for the commission to support HB110. Mark Moffat (for Skye Lazaro) seconds the motion. The motion passes unanimously.

HB181 Criminal Offense Amendments

Discussion around judicial discretion. Judge Trease mentioned that these used to all be mandatory prison (for sex offenses at least) and changes were made to give more discretion. Dan Strong mentioned that we (the commission) are trying to get more info about the 27 cases last year where probation was given on these cases to see how the commission feels about the appropriateness of it.

Motion: Tom Ross motions for the commission to hold HB181. Mark Moffat (for Skye Lazaro) seconds the motion. The motion passes unanimously.

SB63 Board of Pardons and Parole Amendments

BOPP-driven bill. The Sentencing Commission helped forward this to Sen. Pitcher at the beginning of the 2023 legislative session. Intended to clarify the board's role and processes in areas of ambiguity. There is some concern about the standing issue.

Motion: Scott Stephenson motions for the commission to hold SB63. Richard Mauro seconds the motion. The motion passes unanimously.

HB14 School Threat Penalty Amendments

Rep. Wilcox gave the background on this bill. A massive school threat hoax came in and impacted counties across the state. (It turned out it came in from overseas.) We are also seeing an increase

	<p>in school threats across the state committed by students. The intent is to recognize the level of impact of this offense and have the penalty match that. On the suspension/expulsion point, Rep. Wilcox explained that this opens up the possibility of suspension/expulsion, but those decisions are reviewed by a board that considers a list of factors. Rep. Wilcox said the penalty increase was meant to reflect the serious impact of these offenses, not necessarily to deter conduct. He indicated the suspension/expulsion provisions may serve as more of a deterrent. The commission discussed some concerns that the penalty increases (and expulsion) will impact children--many of whom are first time offenders--rather than adults who may be more culpable.</p> <p>Motion: Will Carlson (for Rob VanDyke) motions for the commission to <u>support</u> HB14.
