***HB181 Criminal Offense Amendments***

***SB88 Juvenile Justice Amendments (Sub 1)***

**Motion:** Tom Ross motions for the commission to support SB88S01. Brett Peterson seconds the motion. The motion passes unanimously.

***HB83 Criminal Threat or Interference Amendments***

Concerns were brought up on the definition of harm, but that's existing language and not the focus of this bill.

**Motion:** Richard Mauro motions for the commission to support-in-concept for HB83. Rob VanDyke seconds the motion. The motion passes unanimously.

***HB27 Criminal Code Amendments***

Lengthy discussion about the pantsing / depantsing issue. There was talk about creating a reduced penalty for adults on a first offense. Others felt that would be going too lenient on a serious offense. SOMB Director Dr. Leslie also provided input from her board that they would hope to see clarity on what a "warning" means for juveniles. Also concern about criminally punishing juveniles and young adults in depantsing. There would be more support if intent to sexually driven intent element. Many commission members expressed support for the idea of an intent or mental state element on the pantsing offense. Rob Van Dyke suggested importing "likely to cause affront or alarm" language.

**Motion:** Brett Peterson motions for the commission to hold HB27 for further discussion and action. Richard Mauro seconds the motion. The motion **fails**.

***HB26 Correctional Facility Amendments (Sub 1)***

Brian Redd clarified that there would need to be intent to provide an inmate for the 3F. But it would still be a Class A to knowingly bring one in, even just to the parking lot. There was support

	<p>for switching "at" to "in" in line 152. Brian clarified what it would mean after you have gone through screening.</p> <p><b>Motion:</b> Will Carlson (for Ryan Robinson) motions for the commission to <u>support-in-concept</u> for HB26. Brett Peterson seconds the motion. The motion passes unanimously.</p> <p><b><i>HB16 Sexual Offense Amendments</i></b></p> <p>Dr. Leslie presented on behalf of the SOMB. On the mental health / treatment side, people sent to prison for this offense typically get into treatment 2-3 years prior to the end of their sentence (so that the information/skills they learn are fresh). Some SOMB members were concerned that expanding these 25-year offenses may delay treatment further. Some SOMB members appreciated the clarification in definitions, but are concerned that some behaviors are being elevated to a higher severity. Will moved to support the bill. Craig seconded. Tom made a substitute motion to support in concept. We lost a quorum at that point due to the meeting coming up at 2 PM.</p> <p><b>Motion:</b> Will Carlson (for Ryan Robinson) motions for the commission to <u>support</u> HB16.
