Laura reports that 30 discussion groups and interviews, along with 300 participants, have pulled enough information together for a draft result. Some key findings in the report included:</p> <ul style="list-style-type: none"> • a lack of system-level coordination • administrative burden • siloed systems • workforce shortages • limited access to care • sustainable funding <p>Guiding Principles that can be looked at through finalizing the draft:</p> <ul style="list-style-type: none"> • Access • Alignment • Value <p>Several strategies will be implemented while finalizing the master plan:</p> <ul style="list-style-type: none"> • Support the creation • Strengthen behavioral health prevention/intervention • Integrate physical and behavioral health • Continue to build out Utah's behavioral crisis • Improve the availability of services and support
