# Attachment #2 Educational Services Consistent with State Law and Board Rule

The establishment of a satellite school in Utah demands meticulous adherence to state laws and board regulations to provide quality education while meeting legal requirements. Complying with these standards ensures the school operates ethically, fosters a safe learning environment, and maintains accountability to stakeholders.

## **Utah State Law Adherence**

Utah State Law, specifically Title 53G of the Utah Code related to education, outlines the fundamental legal framework for educational institutions. The satellite school will diligently align with these statutes, including but not limited to:

## **Curriculum:**

Freedom Preparatory Academy's new satellite online school, Freedom Preparatory Virtual Academy (FPVA), will adhere to state-mandated curriculum standards to ensure quality education.

FPVA will emphasize proficiency in core curriculum aligned with Utah State Standards. The full curriculum will span various subjects, emphasizing mastery and college readiness in line with Utah State Learning Standards.

## Licensing:

## Safety:

These adults will serve as at-home learning coaches and be a key component to the learning success of FPVA students. ## **Reporting:**

FPVA will be Compliant with reporting requirements to the State Board of Education. FPVA will report student progress to parents and guardians weekly for assessments, assignments, and attendance. Quarterly grades and attendance reports will also be reported to provide a thorough overview of each student's academic performance per course and meeting USBE reporting requirements. Attendance will be based on weekly progress and participation in weekly meetings with teachers.

## **Board Rule Compliance**
