

This project was initiated by the State Historic Preservation Office, who led a class in designing historic panels focused on the history of Camp Kearns.

Kearns Water Use and Preservation Element Summary Sheet

Copperton, Kearns, and Magna Metro Townships

State Legislation The Utah State Legislature passed legislation requiring the adoption of a Water Preservation and Use Element by all municipalities (except those communities with less than 10,000 residents) (Utah Code 10-9a-403).

To fulfill this requirement and enhance their ability to addresstheevolving needs of their communities, Magna, Copperton, and Kearns Metro Townships are each working to develop a dedicated Water Preservation and Use element, which will be integrated as supplemental amendments to their General Plans.

Objectives:

- Come into compliance with Utah Code 10-9a-403
- Plan for future water consumption and preservation



Expected Benefits:

- Enhance knowledge of current water use patterns within Kearns
- Identify opportunities for water conservation
- Integrate water with land use planning and decision-making
- Maintain compliance with Utah State Code

Planned Deliverables:

• A supplemental amendment to the Kearns General Plan, which meets the requirements of Utah Code 10-9a-403 for Water Use and Preservation planning.



Timeline:

The Water Use and Preservation Element must be adopted into the General Plan by the end of 2025.
