2) MSD Planning Staff will be working the Planning Commission to review Title 19 Zoning recommendations including Forestry and Recreation Zones, and Commercial Zones. **Planners**: Brian Tucker and Matthew Starley (Discussion)

Commissioners and staff had a brief discussion regarding Emigration Canyon maps and layers in Commercial and Forestry and Recreation zones and omitting commercial and changing designation to preserved open space. Discussed process and noticing for changing zoning. Reduce the number of uses in Commercial Zones and create a set of use standards. Visited the use table to eliminate uses not wanted in the canyon and went through comments received from the commissioners.

Check cashing – Eliminate

Childcare Center – Eliminate

Commercial Kennels - Eliminate

Commercial Plant Nurseries – Eliminate. If there is an interest it could be a conditional use.

Bars and Clubs – Remove Clubs. Keep Bars. Allow as a conditional use. Fast food – Eliminate

Bed and Breakfast Inn – Keep Hotel – Eliminate

Office:

Intensive - Eliminate Medical - Eliminate

Recreational:

Eliminate All

<u>Planned Unit Development:</u>

Eliminate All

Institutional Uses:

Religion – Keep Hospitals – Eliminate Libraries – Eliminate Parks and Open Space – Keep Public Uses – Keep Public Utilities, major – Eliminate Public Utilities, minor – **Revisit – Keep. Require burying lines on new development. Schools Public/Private – Eliminate

Accessory Uses:

Accessory Outside Storage – Keep, as a conditional use. Outdoor dining appurtenant to a permitted restaurant use - Keep Temporary buildings subject to 19.42 - **Review Chapter 19.42.

**Review Chapter 19.06 - Nonconforming Uses:

Commissioners and staff had a brief discussion regarding site standards removing build to line. Change major streets to Emigration Canyon Road and minor streets to all other streets. Discussed 20' setback from a public right-of-way, pathway, sidewalk, walkway, and trails, bike lanes and routes, site furnishing changed to benches, bike racks, and receptacles. Subsection G. Screening, remove the word masonry.

Discussed step-down building height, primary building, fenestration, Roof's and rise/run ratio, offstreet parking standards, and cross access easement.

**Revisit FCOZ Fencing requirements

Discussed meeting in November, and then a workshop.
