RESOLUTION <u>02-2024</u>

A RESOLUTION APPROVING AN INTERLOCAL COOPERATION AGREEMENT WITH WEBER COUNTY, HEREINAFTER REFERRED TO AS THE "COUNTY," AND WEBER FIRE DISTRICT, A SERVICE AREA OF THE STATE OF UTAH, HEREINAFTER REFERRED TO AS THE DISTRICT; FOR THE PROVISION OF PARAMEDIC SERVICES TO WEBER COUNTY, AUTHORIZING THE BOARD CHAIRMAN TO SIGN DOCUMENTS NECESSARY TO EFFECT SUCH PARTICIPATION; AND PROVIDING FOR AN EFFECTIVE DATE.

SECTION 1-RECITALS

WHEREAS, the Weber Fire District (District) is a service area duly organized and existing under the laws of the State of Utah; and,

WHEREAS, the Board of Trustees finds that certain sections of Utah Code Annotated 1953, as amended, authorizes public bodies, including the District, to establish written procedures governing the general administration of the District including personnel, insurance, and related matters; and,

WHEREAS, The Board of Trustees finds that in conformance with the provisions of state law, the District is authorized to enter into such contracts as it finds prudent further the health and welfare of the citizens of the District; and,

WHEREAS, The District entered into a Paramedic agreement with the County in April of 2015, updating said agreement in December 2015, and have agreed to update said agreement in January 2024 to furnish and provide paramedic ambulance services to the area commonly known as the Upper Valley of Weber County ("Upper Valley"), and to the Northwest areas of the County, and to the County at large upon request; and,

WHEREAS, The District is capable of professionally administering and providing these beneficial services; and

WHEREAS, The Board of Trustees finds that entering into and supporting the Agreement is in the best interest of the citizens of the District; and,

WHEREAS, The Board of Trustees finds that it will be beneficial to the District to enter into a contractual relationship with County for the provision of these mutually beneficial services; and,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE WEBER FIRE DISTRICT UTAH THAT:

The Board of Trustees of the Weber Fire District, State of Utah, hereby authorizes renewal of an agreement with the County to furnish and provide paramedic ambulance services to the area commonly known as the Upper Valley and paramedic rescue services to the north/west portion of Weber County as set out in the document entitled "Interlocal Cooperation Agreement for Paramedic Services" between the District and County, said document attached hereto and by this reference incorporated fully herein, and authorizes the Chairman of the Board of Trustees to sign any and all contracts, agreements, or other documents necessary to consummate said agreement; and, authorizes the District clerk to sign any documents as may be required attesting to the fact that the Chairman of the Board of Trustees has been duly authorized to enter into such arrangements on behalf of the District.

BE IT FURTHER RESOLVED that this Resolution shall become effective immediately

upon its passage and as outlined in Section 4 of this Resolution.

SECTION 2 - REPEALER OF CONFLICTING ENACTMENTS:

All orders and resolutions with respect to the changes herein enacted and adopted which have heretofore been adopted by the District, or parts thereof, which are in conflict with any of the provisions of this Resolution, are, to the extent of such conflict, hereby repealed, except that this repeal shall not be construed to revive any act, order or resolution, or part thereof, heretofore repealed.

SECTION 3 - SAVINGS CLAUSE:

If any provision of this Resolution shall be held or deemed to be or shall, in fact, be invalid, inoperative, or unenforceable for any reason, such reason shall not have the effect of rendering any other provision or provisions hereof invalid, inoperative, or unenforceable to any extent whatever, this Resolution and the provisions of this Resolution being deemed to be the separate independent and severable act of The Board of Trustees of District.

SECTION 4-DATE OF EFFECT:

This Resolution shall be effective on the 13th day of February 2024, and after publication or posting as required by law.
