

RESOLUTION NO. 2024-01

A RESOLUTION AMENDING THE BUDGETS OF THE CITY OF KAMAS FOR THE FISCAL YEAR BEGINNING JULY 1, 2023, AND ENDING JUNE 30, 2024, AND RELATED MATTERS

WHEREAS, the Kamas City Council, through its elected officials and appointed officers, has caused to be adopted a Final Budget for the Fiscal Year 2023-2024 on June 13, 2024;

WHEREAS, the Final Budget for Fiscal Year 2023-2024 was duly considered and formulated according to the Uniform Fiscal Procedures Act for Utah Cities and all required notices and hearings were provided (Utah Code § 10-6-101 et seq);

WHEREAS, subsequent to the adoption of the Budget, changes in the expected expenditures and revenues of the City require the amendment of the Budget to better reflect and provide for the City's needs and circumstances;

WHEREAS, the proposed Amended Budget has been duly considered and formulated according to the Uniform Fiscal Procedures Act for Utah Cities (Utah Code § 10-6-101 et seq);

WHEREAS, pursuant to law, a public hearing to receive comment and consider adoption of the Amended Budget was held on February 13, 2024 at 6:00 p.m. at the Kamas City Hall located at 170 North Main, Kamas, Utah; and

WHEREAS, the date, time and place of the hearing, the right of citizens to be heard, the location of the City Recorder's office, and the availability of the Budget for public inspection were published on the Utah Public Notice Website, Kamas City website, and in at least one issue of a newspaper of general circulation in Summit County at least seven days prior to said hearing;

WHEREAS, citizens in attendance at the public hearing were permitted to provide written or oral comment for or against the Amended Budget;

WHEREAS, the City Council of Kamas, Utah, hereby determines that it is in the best interest of the citizens of Kamas City to amend the Fiscal Year 2023-2024 Final Budget for Kamas City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Kamas City, Utah, as follows:

Section 1.1 The City of Kamas, Utah, through its elected officials and appointed officers, has reviewed the revenues and expenditures in all of its budgets for fiscal year 2023-2024.

Section 1.2 The City, desiring not to overspend budget appropriations in any of its funds or departments, desires to adjust revenues and/or expenditures in its budgets for fiscal year 2023-2024 as set forth in Exhibit A.

Section 1.3 The budget changes and amendments set forth in Exhibit A for fiscal year 2023-2024 are hereby adopted.
