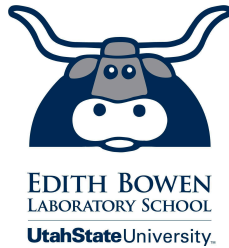

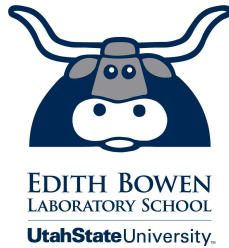

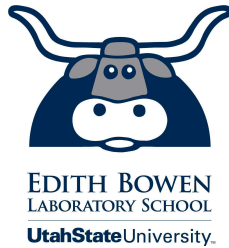
**4. Public Comment**

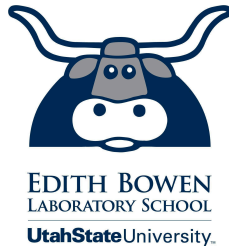
**5. REGULATORY & STATUTORY COMPLIANCE**

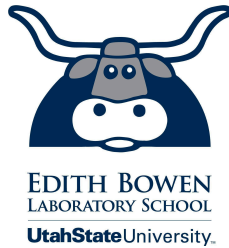

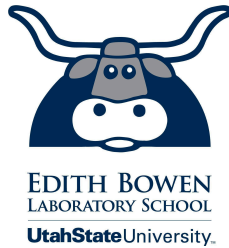

**6. SCHOOL REPORTS**

a. Mid-year data review (discussion)

Dr. Reina presented an overview of the middle-of-year data review. One major observation was that much of the data was collected in December, which includes Acadience Math and Acadience Reading assessments for lower grades, followed by the RISE assessment after the holiday break. Results show that lower grade students

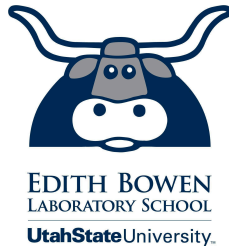
perform better when tested before the break, rather than after, as they tend to lose a lot of progress during the two weeks of Christmas.

In Kindergarten, the goal is to achieve mixed segmentation fluency, with 85% proficiency at the middle of the year. This is significantly higher than last year's 64% at the middle of the year. When considering the data, the current kindergarten data is significantly higher than previous years, which can be attributed to the full-day kindergarten program that has been implemented. The aim is to increase proficiency by 12%, with a projected outcome of 97% of students proficient by the end of the year.

In the first grade, the state monitor goal is to increase nonsense word fluency by 33%. The middle of year data showed an impressive growth from 58% to 81%. In the second grade, the focus is on increasing accuracy by 4%, which was met in the middle of the year. The target is to see 95% of students achieve accuracy. The third grade aims to increase fluency by 3%, with a middle-of-year result of 2%. This means there is still one more percentage point to achieve by the end of the year to move students into proficiency.

Dr. Reina highlighted that although the school is not required to report to the state office or set upper grade goals, we like to collect data for our school. In the fourth grade, the goal is for 85% of students to make typical or better growth. However, in the middle of the year, the number was only 69%. In the fifth grade, the target is to increase accuracy by 10%, and there has been a 2% increase so far. Finally, the sixth grade aims for a 10% increase in accuracy, and the middle-of-year data shows an impressive 13% growth, with 94% of students proficient in accuracy.

Dr. Reina presented the data review in Pathways, which shows students making typical or above growth. These include 53% of kindergarteners, 63% in first grade, 71% in second grade, 87% in 3rd grade, 69% in 4th grade, 75% in 5th grade, and 93% in 6th grade. Dr. Reina noted that for the first time ever, Mrs. Jimenez achieved a 100% typical or better growth rate. This means that she is doing an excellent job of meeting students where they are and getting them to where they need to be.

**Acadiane Math Assessment:**

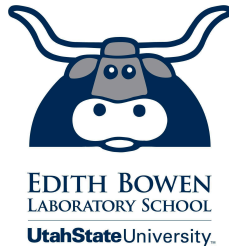
At the middle-of-year, Kindergarten achieved 80% of students making typical or better scores, up from 58% at the beginning of the year. In the first grade, the target was 75%, and the middle of year data shows 85%. Second grade has a state monitor math goal, focusing on computation, and impressive growth has been seen from 60% to 80% high in concepts and applications. At the middle of the year, the result was 82% in computation, with a target of 3% growth. Third grade also aims to increase computation rates.

Dr. Reina concluded by stating that there are very encouraging increases across the board. Teachers are exceptional at adapting and customizing their approach to individual students. The next cycle of assessments will begin in April, and the school is moving in the right direction.

**b. School accreditation replacement plan (discussion)**

During the last board meeting, the need for greater clarity regarding the school accreditation plan replacement was discussed. Mr. Justis mentioned that he and Dr. Reina have extensively discussed this matter and would like to present a model. According to this model, every five years, a year of diagnosis will be conducted on the shared measures. Based on the findings, any issues highlighted in the diagnosis will be addressed by seeking external expertise.

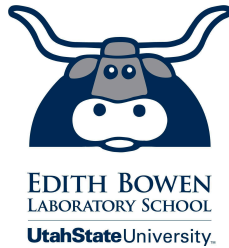
**c. Principal's report**

**i. School highlights**

Mr. Justis provided the board members with updates on the school's progress. He discussed the positive developments that have taken place in both academic and other areas. Principal Justis, Dr. Reina, Mr. Lopez, and Mrs. Seifert attended the conference and they were given the opportunity to present about their learning teams and how they benefit both teachers and students. The presentation received a positive response, with a principal from Florida expressing a desire to implement similar practices at their school.

Edith Bowen was successful in obtaining four grants through an application process. These grants were used to fund a part-time school psychology student who provides mental health groups to students. Additionally, the funds will be allocated to cover expenses to attend an upcoming PBIS conference in

Chicago, any necessary updates to the school's computers, and any improvements to the front entrance to enhance school safety.

Dr. Kozlowski secured two grants this year: one for a scope and digital camera that transmits to an iPad, and another to purchase a classroom set of high-quality binoculars for every student.

Edith Bowen joined a Place Based Learning Network facilitated by the Teton Science Schools. The goal is to become a demonstration site for place-based learning and connect with other schools that have expertise in this area.

Edith Bowen has developed a healthy network of principals in the valley who meet monthly, visit each other's schools, and collaborate on different projects.

Mrs. Rhodes received an award from Primary Care Pediatrics Teacher of the Month.

Mr. Justis thanked the board members for their continued support and thoughtfulness, especially with policy that impacts so many people.
