**Action Items**

1. **Consideration of Ordinance #976 approving proposed changes to RCC Title 8, Chapter 6: Transfer of Water Right.**

Mr. Douglas discussed proposed changes to Riverdale City Code, Title 8, Chapter 6, Transfer of Water Right. addressing the need for adjustments due to changes in landscaping ordinances.

2. **Consideration of Ordinance #977 approving proposed changes to RCC Title 10, Chapter 21: Subdivisions as requested by the Community Development Department and required by the State of Utah.**

Mr. Eggett summarized proposed changes to Riverdale City Code Title 10, Chapter 21, Subdivisions. He acknowledged the mandatory nature of the update by the State of Utah and emphasized the need for compliance and avoiding being a test case for legislative changes.
