6. SWAT Award – Sergeant Nate Taylor and Officer John Blackburn

Chief Gray presented Sergeant Nate Taylor and Officer John Blackburn on behalf of Fairview City. He first read a letter explaining the incident that took place in Fairview City for each officer. On December 7th, 2023, Sgt. Nate Taylor and John Blackburn responded to assist Fairview Police Department on an incident of Domestic Violence where a firearm was used. The letters were to thank both officers for their participation.

Chief Gray also presented Officer Ben Swapp on behalf of Mt. Pleasant Police Department the Life Saving Award. Officer Swapp responded to a call where the individual was not breathing. Officer Swapp administered CPR and Narcan and was able to bring the individual back.

Mayor Olsen also thanked the Officers for their work.

7. Resolution 2024-02 Adopting Fire Department Standard Operating Procedures- Chief Sam Draper

Fire Chief Sam Draper was not present. Councilmember Cade Beck stated these SOPs were most likely just updated and wanted to know if we knew the changes that had been made. Councilmember Beck felt like there could be some information added to the SOP's.

Also questioned if the Fire Chief had an approval limit himself. Mayor responded that he would fall under the City policy and would have to have anything approved over the limit that the City policy has for each department.

Some discussion took place on whether we should table the resolution or approve it with some of the changes required.

Changes that Councilmember Beck would like to see added would be the probationary period, what the hiring process is and what are causes of suspension.

8. 7:00 PM Zoom Call from Larson & Company Audit Report – *Jon S. Haderlie*

Jon S. Haderlie presented the audit report over zoom. He explained to the council the financial statements and the auditing process. He commended the staff for their response in any items that were requested during the audit. During the audit process he asked for some very invasive materials, and all were rapidly delivered. Jon discussed one change that be implemented with accounts payable procedures however staff have already made those changes. This change specifically has to deal with how reimbursements are done with employees. The full audit report will be delivered to the council by the next council meeting.

9. Discussion/Action on the following items:

a. Sixth County Regional Information – *Cade Penney*

Utah Outdoor Recreation Grant is open. Emailed the information to Dave. Mr. Penney talked to Dave about applying for it to do some seating for the Contoy Arena.

Assistant to Firefighters AFG opens on the 29th of January. Mr. Penney also emailed this information over to Dave. He and Dave will see if Mt. Pleasant City can qualify to redo the fire station. Dave would like to get the council's blessing to proceed with going after this grant. Cade Penney will get more information to see what all is involved.

CIB will be sending out a survey in March; CIB has been very minimal. A survey will go out in March. Council needs to come up with 3 prioritized projects for the year.

There is a BEAD broadband equity access and deployment grant. For unserviced area for internet. If there are any areas that we know of that are unserviced, they can investigate that area.

Sixth County has a new building going up in Richfield. Sixth County will adopt a new name called R6. In the future emails will change and Cade will present them at that time. R6 will do a regional growth summit. They will invite Mayors and Councilmember's. This summit will be held on May 21st, 2024, at 5 PM. The Governor will be in attendance. Cade will bring registration to the council.


