- 6. Approval of December 12, 2023, Board Meeting Minutes.
 - Motion to approve December 12, 2023, board meeting minutes made by Scott, second by Mike.
 - All present members Jim, David, Ryan, Gordon, Mike, Kevin, Boyd, Val, and Scott voted aye. Unanimously approved.
- 7. Presentation of financial report.
 - Presented by Boyd
 - 2023 financial report:
 - 100% of the year 2023 has expired
 - Ambulance Revenue 101.0%
 - Property Taxes 95.8%
 - Impact Fees 94%
 - Capital Expenses 83.3%
 - Payroll 92.6%
 - Total Expenses 90.1%
 - 2024 financial report
 - 2.19% of the year 2024 has expired
 - General Fund Revenues 0.2%
 - Payroll 3.3%
 - General Fund Expenditures 3.2%
 - Closed on the TAN note, it's been funded.
 - Overall current fund balance ~ \$10M in the PTIF and ~ \$4M in the checking account.
 - Motion to approve the 2023 and 2024 financial reports made by Mike, second by Gordon.
 - Roll call vote: David, Ryan, Gordon, Mike, Boyd, Val, Scott, and Kevin. All present members voted aye. Passes unanimously. Jim was absent.

- 8. Open Meetings Act Training
 - Presented by District Attorney Amy Hugie
 - Jim, David, Ryan, Gordon, Mike, Kevin, Boyd, Val, and Scott were in attendance for the Open Meeting Act training. Rob was absent.
- 9. Forms of Completion
 - Presented by 'Andrea
 - Complete both the Conflict-of-Interest Form and the Ethical Behavior Pledge that have been e-mailed to you. Please have them completed by the end of the month.
- 10. Resolution 01-2024, a resolution approving and authorizing the execution of a purchase agreement for fire apparatus between Weber Fire District and Rosenbauer.
 - Presented by Battalion Chief Lund and Captain Tom Sexton.
 - We initially got a bid from Pierce of just under \$1M. Rosenbauer bid at a little over \$800K. Rosenbauer approached us and asked what we were looking for. After discussing our needs, a price of \$680,294. was offered with a completion date of 2026. This is a savings of approximately \$300K from Rosenbauer's original bid
 - Motion to approve the purchase agreement between Weber Fire District and Rosenbauer made by Boyd, second by David.
 - Roll call vote: Scott, Val, Boyd, Mike, Gordon, Ryan, Jim, David, and Kevin. All present members voted aye. Passes unanimously. Jim was absent.

- Chief Clark thank you for approving the Engine. Chief Lund and the committee did a lot of work getting the best truck for the best price. They did a lot of leg work to obtain the savings for our taxpayers.
- Chief Draheim Weber County has approved the Horton ambulance for Station 62, it should be here the end of July. \$50,000 per truck for the paramedic contract was approved. We have a meeting setup with Roy to discuss the licensing.
- Chief Taylor the Pub. Ed. school shows schedule has been emailed to all of you. I would like to invite you to come to see a great show. We obtained a Smokey Bear costume after jumping through many hoops.
