Curt Shelley asked for Chief Hennessey to go over the other bids and why this is the truck that has been selected. Chief Hennessey indicated that the truck we are purchasing has a 400 gallon tank on it the other ones have smaller tanks. Also to get a truck that we can order would be at least 3 years before it could be delivered. Chief Hennessey went over the other two trucks that would not meet our needs.. To order a truck would be over \$300,000 and we wouldn't see it for three years. He also discussed a BME truck that they had as a demo which was actually sold. The BME would be about \$315,000 and will take 3 years to produce. Other type 6 brush trucks use standard suspensions and aren't really built to handle the off road terrains. This truck we are talking about today is built to take up to lots of abuse.

Mack asked for a second on the motion to approve the purchase of the Brush Truck being discussed. The motion passed unanimously
