- "Kids who use our telehealth services are back to school learning in less than a day that's huge," Nurse Parks said. "That's half a day or less that they miss school. For example, a student who has strep throat, on average, will miss two days of school or more across the nation. Students who use our program miss half a day" Nurse Parks also spoke about the "Sight Buddies" vision program, a partnership with Wasatch Vision and run by Charity Vision International. She said 40 students were identified this fall to be taken on a field trip to the eye doctor to receive glasses at no cost through a school-based nomination process. "This program - and all the other programs that we offer - changes lives," Nurse Parks said. "When we keep kids in school, they learn. When we help kids see, they can read"
- Board Member Allen shared her appreciation for the program as a mother of four, and also noted she and Board Member Dickerson were fortunate to have the opportunity to volunteer for the Sight Buddies program. "It is true if you can't see, you can't read," she said. "And some of these kids, it's mind-blowing to them when they can finally see. Basic stuff like that, it changes the trajectory of a lot of little lives and it's awesome. So thank you for everything you guys do."
