 Tessa Scheuer reported on the status of the exams following a meeting the previous week with WPI staff. Plans are to be able to proceed sometime in April following the 30-day blackout after the March 1st exams at RWAU. Chad suggested providing an overview of the process during the WEAU Conference. There are questions of how accommodations will be handled, such as dyslexia, once the new format is in place. There are also other questions that need to be answered. We will have procedures for testing prior to any fee changes—while the fees are being paid by DWQ, and different procedures after the fees change, if approved by the legislature. Once DWQ has received an application, the information is passed to PSI. Once PSI has the information, they contact the examinee directly with information on registering for the specific location, date, and time for testing. There are questions about where the testing locations will be.
