Community Council,

We recently met with Sharleen Hammer, the district finance secretary over Trust Lands. As we met, we were informed that we would not be able to allocate a large amount of money approved for salary and if we wanted to move it to another approved category on the plan, we would need your approval.

First, let me explain.

Over the summer we hired a Spanish teacher. We planned on using Trust Land funds to pay her salary. She quit after two weeks. We got approval to pay a long-term sub to teach the class. We are still waiting to see if we can pay the sub out of Trust Lands. However, the difference in pay is substantial.

With that said, we are proposing to move:

1. \$25,000 to technology for additional classroom projectors and Chromebooks
2. \$1,500 for supplies to make up the difference due to the increased price of the stage piano that you approved.

We need to submit an amendment to the plan to the board. If you approve of the change, please send me an email stating that you have reviewed the proposed changes to the budget allocations and that you approve. If you do not, you are welcome to state that as well.


