Chairman Swenson addressed the announcements by emphasizing the need for volunteers to assist with various tasks such as building floats, staffing booths at the fairgrounds, and overall planning. They mention the support from sponsors and local businesses, as well as the photographer offering their services for the beauty pageant.

 - a. Initial Review of Leeds Subdivision Code in accordance with SB 174 by Hansen Planning Group

Chairman Swenson asked Craig Hall and Scott Messel to lead the discussion to new code enforcement regulations introduced by the state of Utah. Scott and Craig Hall, the town attorney, provide information on Senate Bill 174, which aims to streamline the subdivision approval process.

Craig Hall provided a Power Point of highlights for key points of the legislation, including the designation of an administrative land use authority, the limitation of review cycles for subdivision plans, and the requirement for applicants to respond to feedback in writing.

There is a recommendation for developers to engage in a pre-application meeting to address potential issues early on. Craig stresses the importance of applicants submitting complete plans and complying with relevant codes to expedite the approval process.

The town council is urged to review the model ordinance provided and make recommendations for adoption before the December 1 deadline.

The speaker discusses the need to review and update the town's zoning ordinances in accordance with SB 174, emphasizing the importance of clarity and accessibility for residents and developers. They suggest involving the planning commission and town council in the process to ensure comprehensive feedback and alignment with community needs.

The floor is opened for questions and discussion.

b. Deliberation on Key Points Arising from Work Session, Short-Term Rental (STR) Draft Proposal by Commissioner Darton

Commissioners along with Mayor Hoster discusses with Attorney Craig Hall, and Scott Messel the need to review and potentially update the zoning ordinances of the town to comply with Senate Bill 174. They emphasize the importance of collective input from the staff, planning commission, and town council to ensure that the ordinances are clear and accessible to the public. Additionally, they mention the need to improve the town's website to make it easier for residents to understand the processes and regulations. The speaker also addresses the involvement of the town council in the planning commission's meetings and the importance of collaboration between the two bodies. They

conclude with updates on other agenda items discussed during the meeting, including short-term rental regulations and upcoming community events. 10. Staff Reports: None
