Councilmember Hedglin stated she would like to discuss this agenda item at a future work meeting. She expressed a worry regarding the impact to local businesses.

Assistant City Manager Gallegos presented the current reporting regulations to the Council. Planning Commission Chair Bennett attended the meeting to discuss this agenda item with the Council as well. She pointed out the need to update the Monticello City Code to reflect requirements from the State of Utah. She asked the Council if they had any ideas or suggestions for this code. Bennett explained the training requirements of the State of Utah. This agenda item will be revisited at the March 26th meeting.

12. Administrative Communications**Minutes:**

Kulow inquired if the Council was receiving the emails sent from the Utah League of Cities and Towns. Senate Bill 185 was the subject of the recent email. A letter was sent to the Council regarding a dispute between the FBO at the Airport and a Citizen. Kulow explained the situation and steps that were being taken to resolve it. He updated the Council about the City website. He asked each council member to provide an information page.

Gallegos stated she will be revising the Board of Adjustments code along with the Planning Commission code.

The Recreation Committee will have a movie night in March.

Mayor Bailey recommended everyone attend the Caucus night in March.
