Patrick Horrigan came to USDC in 2021 and is currently working on coping skills with a discharge goal set for 2025. USDC Procedure and Policy:

The following updates have been made to policy 50.03.01 regarding Visitors for Individuals/General Public:

A definition for "next of kin" was added to the policy, with clarification provided by Clover Meadows.

All visitors are required to report to the switchboard upon arrival, sign in, and obtain a visitor badge. Visitors must prominently display the badge while in the building and return it to the switchboard upon departure.

During annual person-centered plan (PCP) meetings, parents and guardians may be issued a badge for use throughout the year. While signing in at the switchboard remains mandatory, those with a parent/guardian badge do not need to pick up or return a visitor badge.

In case of loss or theft of a parent/guardian visitor badge, USDC must be notified immediately. Replacement badges are issued by the switchboard.

Weekly youth volunteer groups are exempt from switchboard check-in. They are supervised by the volunteer coordinator and recreational staff, trained, and monitored during their activities. They may assist with transportation but are not permitted in private areas unaccompanied.

Upon signing in, the switchboard notifies the appropriate area or department of the visitor's presence. Visitors requiring assistance may request an escort to their destination.

Failure to adhere to policy guidelines may result in adjustments to visit availability and location as determined by the treatment team. Any accommodations or exceptions to this policy must be discussed and approved by the treatment teams and parents/guardians, outlined in the individual's PCP.

Because of the changes that are being implemented, this policy will be effective around the beginning of March 2024.

Approval to pass the Visitors for Individual/General Public Policy 50.03.01 was unanimously approved.

SB 113 Discussion

The discussion focused on Senate Bill 113, a critical legislative issue for the governing board. Scott Pingree reached out to gather information about the bill. The proposed bill eliminates the governing board's role in land sale and water rights. The bill grants the state legislature authority to make decisions regarding land valued over \$500,000. Members of the board have been collaborating with the legislative liaison and Senator Buxton, the bill's sponsor, and previous director of DFCM, seeking a compromise in the bill's language. Proposed changes include providing a 30-day notice to the board, consideration of the master plan, and addressing additional needs. Concern was expressed about the sponsor's attempt to limit the time for board decision-making.

Dr. Smith emphasized the importance of aligning legislation with the master plan to avoid misunderstandings about land availability. Additionally, Dr. Smith mentioned long-term possibilities for the land, such as developing housing for individuals with autism and providing respite services due to increasing population demands.

Scott Pingree stressed the board's responsibility to collaborate with the administration for the well-being of those served. Concerns were raised about SB 113 potentially diminishing the board's role in land and water rights decisions. The discussion emphasized the importance of considering the impact on the well-being of individuals served by USDC.

Scott Pingree asked to clarify what the sentiments are within the group regarding SB 113. The board aims to avoid advocating or operating in an uninformed manner. Tonya expressed deep concern over the potential elimination of the board's role in land and water rights sales. Our focus is on how the board's involvement affects the well-being of those we serve. Scott Pingree emphasized the importance of understanding the context and advocating for our constituents. Paul Smith noted that the constitution of the state isn't immutable, and efforts can be made to improve the legislation's language. Tracy underscored the board's independence from the department and its authority over legislative matters. Dr. Smith emphasized the importance of not exacerbating the situation.

Dr. Smith proposed adjourning the meeting. Tim Mathews seconded the motion.
