## **ORDINANCE NO. 2024-XX**

An Ordinance of Virgin Town Council, Virgin, Utah Adopting the Virgin Town Wastewater Study 2022 Update performed by Sunrise Engineering (signed and stamped February 22, 2023)

## RECITALS

**WHEREAS** Virgin Town ("Town") is an incorporated municipality duly organized under the laws of the State of Utah;

**WHEREAS** pursuant to Utah Code Annotated, Title 10, Chapter 3b, Section 301, the Virgin Town Council ("Virgin Town Council") is designated as the governing body of the Town;

**WHEREAS** Virgin Town contracted with Sunrise Engineering to perform a wastewater study in 2022 analyzing Virgin's current and future wastewater needs and Sunrise Engineering presented their final report to Virgin Town Council on February 21, 2023; and

**WHEREAS**, this wastewater study performed by Sunrise Engineering recommends standards requiring 90% nitrate removal in commercial, and acreage per residential households of one acre or more, and finds poor soil percolation in some areas of Virgin; and

**WHEREAS** the Town Council and Town Staff have determined that it is in the best interests of the health, safety, and welfare of the Town and its residents to insure that all new construction of buildings and structures that necessitate the installation of a septic system, including residences and commercial buildings, be constructed in a manner that complies with recommended wastewater standards as set forth in this Virgin Town Wastewater Study 2022 Update (signed and stamped February 22, 2023) from Sunrise Engineering;

## NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF VIRGIN, UTAH:

*Section 1*: Adoption of Virgin Town Wastewater Study 2022 Update by Sunrise Engineering. The Town hereby adopts the Virgin Town Wastewater Study 2022 Update (signed and stamped February 22, 2023) by Sunrise Engineering including all appendices.

*Section 2.* Severability. If any section, clause, or portion of this Ordinance is declared invalid by a court of competent jurisdiction, the remainder shall not be affected thereby and shall remain in full force and effect.

*Section 3.* Conflicts/Repealer. This Ordinance repeals and supersedes the provisions of any prior ordinance in conflict herewith.

Ordinance 2024-XX Adopted March 19, 2024 *Section 4*. Effective Date. This Ordinance shall become effective upon adoption by the Virgin Town Council and execution by the Virgin Town Mayor. Until that date current ordinances for code enforcement remain in effect.
