I am writing in support of the current location of 10 North Center Street for the Wayne County Farmers' Market. It is the only appropriate location. Others will share their reasons, and I will share a few of my reasons. Reminder, I speak for myself and only myself.

1. This location overwhelmingly maximizes the visibility needed to catch the eye of passing tourists and visitors. When they see the activity next to Center Street, it will encourage them to stop, socialize, and ultimately spend money at both the Market and the Mainstreet businesses. This Public location provides ample Public Parking next to public roads. In addition, this location minimizes the direct impact on Private Property, Citizens, and other Businesses.
2. Another location would lead to lower Market attendance and, therefore, less tourist money staying in Wayne County. Ultimately, another location would simply lead to the end of the Market.
3. The working relationship between the Market (Private) and Torrey Town (Public) is mutually beneficial. More tourists who stop = more money spent = more Special Event Sales Tax collected for Torrey Town Coffers to pay for any impact on Public Right Aways. In addition, Center and Main Street Business will benefit from increased tourist traffic which = more Sales Tax collected.
4. We can't mine, drill, or log. Tourists, and Weekend Visitors from the Wasatch Front, have become one of the few resources available for Wayne County. The Market is one of the ways we should capitalize on this resource. We have been discovered and we can't be undiscovered. Let's do our best to make Lemonade.
5. Making the Public Restrooms at the Torrey Town Park available to use during the Market is a good solution and option. Until a better solution can be devised, this is the correct and proper use of a Public Restroom. I believe Torrey Town receives enough Special Event Sales Tax to easily cover the cost of maintenance for this. In addition, this should lessen the impact on the bathrooms of Center and Main Street Businesses.

In closing, if you want to discuss Road Safety, then be sure that every Torrey Business is treated the same with similar rules and restrictions. What you require from the Market should be required by other Torrey Businesses, both brick and mortar, as well as mobile.

Dear Torrey Town Council:

I would like to give some background regarding the Torrey Farmers market.

In the early 2,000s I was fortunate to work with a non-profit board tasked with marketing Wayne County tourism. We were very successful, growing our budget from around \$85,000 to around \$325,000. When our five year contract was up for renewal, the County took over the program, leaving us with a highly functioning board of directors. We discussed how we might move forward, filling a need for our growing community. A method of uniting our businesses came up as a positive use of our skills. Thus, the Wayne County Business Association was born.

We came up with short term and long term goals. A pedestrian/bike path

was one, and promoting a farmers market was another. With the inspiration from Randy Ramsley we embarked on this program. This has proven to be a success, providing the public with great local food, a social event, and opportunities for local small businesses to prosper.

When issues such as safety came up they were solved creatively by good management and dedicated volunteers. As compared with the burger truck

parked in the Chuckwagon parking lot on most summer evenings, pedestrians are much safer off the highway during the four hour Saturday market.

Recently a few people have decided to resent the success of the market. This negative attitude seems to emanate from Jamie Austin's afternoon garage drinking parties around the corner. Last summer this devolved into alcohol infused bullying and physical confrontation.

Thankfully, cooler heads prevailed, and no one was hurt.

I have had a recent conversation with Sherri Clark about the market's effect on the Chuckwagons' business. She cited several negative effects: customer and employee parking; vendor use of their dumpster; restroom usage; making change for customers to spend at the market; and safety of pedestrians. These are all valid issues. She suggested

moving the market to the city park just around the corner. Most comments that I have heard or read feel that the current location provides the best visibility for tourists to notice the market. While this issue of visibility to tourists is an important concern, if the market was located at the park I believe it could be solved with signage as other communities have. Proper sandwich boards at both ends of town as well as good signage at 1st East could overcome the problem. We locals will find the market. The parking problem could be taken care of by using the church parking lot. The other negative effects on the Chuckwagon would go away as well. With more room we might even expand to include prepared food stalls. As the market has developed over the years many volunteers have stepped up to resolve issues. The creative energy that has gotten us this far could make the market even better.

Dear Mayor and Council members,

I understand the town council is considering the future of the Farmers Market. My family uses the market regularly and I believe it is a great benefit to the community.

The Farmers Market is a place to meet friends and neighbors who we might not encounter otherwise. Judging from the vigorous conversations and social interactions we witness there, we are not alone. The Farmers Market acts as a bonding agent for the community. It is also popular with the town's many visitors and tourists.

We also depend on the market as an irreplaceable source of nutritious homegrown food. For those vendors supplying that food, it is an important income source. For those selling their crafts, it is a way to share their products without the burden of expensive overhead. You could call the market an entrepreneurial incubator.

I understand that Shari and Mike are concerned about the negative impact of the Farmers Market on their Chuckwagon business, I respect them and believe they are credible, so I take them at their word. However, it is hard to believe that the inconvenience of having the Farmers Market nearby once a week compares to having the Capitol Burger truck in their parking lot several times per week.

The current location seems ideal. If a new location must be found, I believe this is a problem that can be solved. We have a large park with lots of space for parking and vendors. The Mercantile has an expansive parking lot.

There is also a concern about traffic and safety. I am sure this is also a problem that can be solved. Many other communities have similar concerns about special events but have managed them well. This past summer there was a shameful act of violence by individuals opposed to the market. In any other community, there would have been arrest or litigation. It is a testament to the good and forgiving nature of our community that those remedies were not used. However, intimidation is an act that responsible public officials should guard against. A vocal minority willing to engage in inappropriate confrontation should not be allowed to thwart the wishes of the rest of us.

I am confident the council has the intelligence, skills, and good intent to work out solutions that may not be perfect but are reasonable and acceptable.

Dear Torrey Town Council members,

I am writing to urge you to please vote "yes" to keeping the Torrey Farmers' Market at its current location on Center Street.

The current location has high visibility and easy access for tourists, which vendors have told me is vital to the success of the market.

Since the market is currently on Town property, it generates special event sales tax revenue, which helps everyone. I also personally believe that the Center and Main businesses benefit from the increased visitor presence around the market.

Other potential locations for the market have been discussed, but these all have flaws which would likely result in the demise of the market, due either to lack of public visibility (for visitors) or parking problems. I strongly feel that the current location is the only one that is workable, and any concerns from opponents can be worked out through mutual discussion in good faith. If there are concerns about excessive visitor bathroom use at Center and Main businesses, the public bathrooms at the town park could be opened, with signs to direct the public there. It seems the special event sales tax collected at the market would be enough to cover this small expense. Similarly, any concerns about pedestrian and car traffic on Center Street, or potential parking issues, could also be addressed, as was shown by the efforts by the market last summer. If those efforts were considered to be inadequate, that can be discussed. Those of us who support the market are willing to work together in a peaceful, non-violent fashion to help alleviate any concerns.

I believe the Torrey Farmers' Market presents the best that Torrey has to offer for everyone. As a full-time Torrey resident, for me it is so much more than just a venue to buy local food—it is also a chance to catch up with friends in a fun atmosphere, chat with the local food producers and crafts-people, hear some music, and talk with visitors (who overwhelmingly love the market and are glad they "saw the tents" when they passed by on Main Street). It is a welcome and inviting weekly "public square" for locals and visitors alike—it would be a shame if it didn't survive.

The location of the Farmers' Market is perfect-there is ample parking everywhere and all the incoming visitors can see it from Torrey's Main Street. Dear Town Council:

My concerns about the farmers Markey are Listed below:

It is not the responsibility of Torrey Town to provide a location for the Farmers Market, they are unaffiliated with Torrey Town.

Why aren't the Farmers Market participants paying for or leasing the space they occupy? Every other business in Torrey does including the Fourth of July vendors. The food trucks make arrangements with property owners to operate.

We have very few Farmers Market vendors that are tax paying Torrey residents.

I do not think we should have input in our town meetings from anyone other than Torrey voting and taxpaying citizens, unless we need expert subject matter from invited guests and members of the P&Z committee. Not open mike events where anyone from anywhere that has an opinion is allowed to speak.

Farmers Market should not operate a business on road right of ways. The Mayor and Town council seem to cater to and treat them as a special interest group, or a non-profit organization. They are a business for personal profit and should be treated as such.

I have personally witnessed several potential accidents that could have been fatal, including myself. At the last council meeting I attended, every council member including the Mayor, made statements about safety concerns, yet they continue to keep this going at the same location.

It is not my responsibility to subsidize this event through my tax revenue.

The potential lawsuit that is inevitable will make the citizens of Torrey liable, (town council and Mayor have stated safety concerns in public meeting) not the vendors, regardless of their so-called insurance.

We have outgrown the current location and do not have the infrastructure (lack of parking, foot traffic control, visibility, lack of traffic lights etc.) to support the current location.



We have a small fruit farm, and have been happy to share our peaches, plums, pears and apples with visitors and residents of Wayne County during that time. With the legislative change a few years ago, we have been able to sell homemade fruit breads as well. We have greatly appreciated Torrey's willingness to host the market, and Dianna Poulton's suggestions and help.

I believe part of the market's appeal lies in its location at Center and Main. This is a letter (sent by email) in support of the location of the Torrey Farmers' Market.

I imagine many people will speak to the benefits of the farmer's market location at Center St. and Main St. (rt 24) in Torrey. Benefits include the food and other items we can buy there, the financial benefit to the community of the money the vendors make, and the tourist information service provided by the vendors, which is good for the other businesses in town.

I would like to speak to the benefits of a cluster of businesses to a community.

There are currently three businesses at the crossroads of Center and Main on Saturdays: the Chuck Wagon, the Old House, and the Farmers' Market. These businesses provide an attractive business cluster that draws locals and tourists to spend money in Torrey, and leaves tourists with a good impression of our town.

As a town grows, new problems develop, for instance traffic, parking, and housing, especially for seasonal workers. These problems can be solved by cooperation.

I support the farmers market at the location on rt 24 and Center St. because I support the growth of businesses in Torrey. I also support best business practices including clustering, and cooperative solutions to the problems that the growth causes. Can you imagine what it will be like if someday we need ... a traffic light ... where rt 24 and rt 12 meet?

I have been a vendor for several years. The following are the products that I display and sell at my booth: Cherries, Apricots, Plumbs, Peaches, Pears and Apples.

The small commercial garden that I Have at Notom produces radishes, lattice, Swiss chard, cumberers, tomatoes, peppers, zucchini, winter squash, pumpkins, and melons.

Some of the fruit and vegetables that I sell are not produced in the higher elevation of Wayne County. I have many residents of the county buy products at my booth.

The first site for the Farmer Market was on the west end of town by the Entrada Book Store. Hardly anyone stopped. I didn't even make enough money to buy gas to get my products from Notom to Torrey. After two years I quit. A while after that I noticed that a new Farmers Market had started on Highway 24 between the Chuck Wagon and the LDS Church Building. I found out the Dianne Poulson was the director. I contacted her and became a vendor. I did quite well there. When it was moved again to its present location, I was worried. However, I had no reason to worry. I have done even better where it is now.

I believe that the reason the Farmers Market is doing so well at its present location is because it is located close to several other businesses. It seems that each business helps contribute to the success of other businesses close by. When I sell peaches, I often tell the customer that peaches are even better with ice cream. Quite often I see that customer walk toward the store or the ice cream shop. 



Dear Torrey Town Board

I am sending this letter in regards to the issue of the Farmers Market remaining on center street. I am surprised this has become a topic once again since it was voted on last year when it became an issue. The Board voted that the Farmers Market could remain on Center street for the remainder of the year, but felt it was a dangerous, crowded area and needed to be relocated. It has been since October since the market ended and it is now time to start again and now you have it back on the table. What has changed since last season?

First of all, I personally do not want the Farmers Market to end!! It has grown over the years and it is a highlight for everyone during the summer/fall months. It benefits many in the county and beyond. I feel there is a better place to hold this event besides Center Street. Here are my concerns

1) There is not enough parking. The parking is taking up the highway, and center street. This causes problems with my business. We do not have enough parking for our own customers let alone parking for employees. Yes, we do benefit from the influx of people at the market, but we also lose business. We have lots of customers come in after Saturday and said they were planning on stopping in to purchase items, but there wasn't parking, so they went elsewhere.

2) Safety for the people with all the congestion. I instruct all of our employees on Saturday to back into the parking spot (if there is one) When we try to leave during the market, people do not pay attention to what is going on around them. People stand in the middle of the road, they do not watch their kids. I would hate to see

someone get ran over from all of the congestion on center street. Also more likely than not the little green men in the middle of the highway warning people to slow down has been hit and are in the driving lanes of the highway. The cars parking on both sides of the street and the little green men make Highway 24 very dangerous.

3) There is a bathroom issue. We have provided porta potties at our own expense because our septic system can't handle all of the people lined up to use our bathroom. Therefore we shut our own bathrooms down to deal with the influx of people. That is not fair for us or our customers. Personally, if there is an option of a porta potty or a clean bathroom in a building, I am using the one in a building as does everyone else.

4) We have people come in to solicit us for change. The Chuckwagon is not a bank. We have what we need to get us through the weekend. We shouldn't have to worry about keeping enough for the Farmers Market also.

5) The market vendors also use our dumpster, although we have signs for "chuckwagon use only"

I think the park would be optimal for everyone. For many reasons

- 1) It is only 1/2 block up from where it is already being held. It will get the parking off the highway and the congestion off center and main. There are bathrooms with running water and real toilets. There is the excuse that it can't be there because the pavilion gets rented out. I have never seen a sign at the park telling anyone that it is closed during times when the pavilion is rented. It is still available to be used by others. If the renters had this info ahead of time, I feel it would still be rented by the ones wanting to rent it.
- 2) The Farmers Market has a following and I do not see any reason people wouldn't go there because it was 1/2 of a block up from the Center street location.
- 3) The grass and trees are inviting and would make it a more enjoyable area to hang out and experience the market.
- 4) It would solve my bathroom issue, parking issue, dumpster issue, safety issue, change issue.
- 5) And most importantly. It is safe and away from the highway.

I know that the huge majority of the public and market goers do not see a problem with it being held on center street. Why would they be concerned by anything I have discussed in this letter? It doesn't affect them! But it does have an impact on my business.

I would love to see it continue and grow! Move it to the park. Or somewhere else that is big enough. Come together as a town and promote it at a safer area. Put up nice, permanent sign advertising the event all season so people are aware that it's always there with a nice accommodating area for the event.

Thank you for your time and addressing our concerns with this issue.

Having restrooms available would encourage people to linger longer, spend more money and explore what Torrey Town has to offer. It's a win/win for the local economy as well as free advertising for the town and Capitol Reef.

Thank you for allowing the public to comment on this situation prior to decisions being made. We all benefit from the Farmer's Market, whether it be from a private standpoint or a tool for the advancement of tourism, and we look forward to it continuing and flourishing.

I have enjoyed meeting and getting to know locals who I expect I will have lasting relationships with, as well as conversing with tourists from around the world who have come to partake in the astonishing beauty of our area.

I love the location of the market and think that many tourists stop because of its visible and convenient central location. My wife Susan and I reside in a house on SR 12, and she has had a booth at the market for the past 2 years with which I assist. We have enjoyed our experience at the market, an experience that has enabled us to meet both other residents and tourists from all over. In addition we have found the location to be one of the main factors in both the success of Susans booth and the overall success of the market. The location is central to the town and businesses catering to tourists, so both the customers and we and fellow market vendors benefit from this. In addition I feel said businesses surely have to also benefit from those seeing a market who might otherwise not stop."Farmers Market" conveys fresh produce, other foods and wares not normally found in such a remote setting to travelers in this remote setting. For comparison there is a Farmers Market tent erected in a vacant lot on the outskirts of Richfield. While I'm sure there are good wares to be had there, the setting is not even close in a feel good ambiance to what we have here in downtown Torrey. We should all appreciate that we can in fact hold our market in such a great setting.

Knowing there is opposition to this location with the main opposition being public safety, I would pass along the following: I am retired from a career in large international resort operations where I was both a risk manager and on the executive safety committee. In both capacities I was charged with scrutinizing each and every factor in a wide range of public use settings, in other words I was involved in dialing in on every detail regarding the risk to the public/guests. This has provided me with a unique perspective on assessing said safety concerns. With that said, I can assert with confidence that I never saw any significant or even minor safety issue during my time at my wifes booth at the Farmers Market present location, an amount of time that covered most days there over the past 2 years. The traffic warnings and pedestrian controls implemented last year worked great, so much so that the infrequent passing vehicles were moving slower than a walking pace.

In conclusion, I cannot imagine a better location for this great market in a tourism dependent town, and I cannot fathom any reasons to not continue to stage it there. Bottom line, we are fortunate to be able to stage our market at the current location.


