Salt Lake County Sheriff Presentation

Sheriff Rosie Rivera delivered a PowerPoint presentation entitled: Re-Established Law Enforcement Bureau (Model Contract for Salt Lake Valley Law Enforcement Service Area (SLVLESA). She reviewed transition goals of maintaining service levels and taking care of the people providing services. She also spoke of the vision and SLVLESA-specific goals.

He reviewed the Vision and Mission Statement for Unified Police Greater Salt Lake (UPD); a draft of the current organizational chart as of January 23, 2024; the importance of UPD providing local control; how UPD is expertise based; SLVLESA Tax Revenue for 2023; and key reasons for working together with Copperton Metro Township.

The County has concerns about SLVLESA being part of the interlocal agreement because it does not want to be responsible for costs.
