## RESOLUTION NO. PC-2024-0015

A RESOLUTION BY THE OREM CITY PLANNING COMMISSION APPROVING THE SITE PLAN OF HOLIDAY OIL LOCATED GENERALLY AT 1981 SOUTH GENEVA ROAD IN THE C2 ZONE.

WHEREAS on August 21, 2023, Brent Neel filed an application with the City of Orem requesting the Planning Commission approve the site plan of Holiday Oil located generally at 1981 South Geneva Road in the C2 zone; and

WHEREAS a public meeting considering the subject application was held by the Planning Commission on March 20, 2024; and

WHEREAS 138 notices were mailed to the property owners within 500 feet of the property; and

WHEREAS the agenda of the Planning Commission meeting at which the subject application was posted at the Orem Public Library, on the Orem City webpage and at the City offices at 56 North State Street; and

WHEREAS the matter having been submitted and the Planning Commission having fully considered the request as it relates to the health, safety, and general welfare of the City; the orderly development of land in the City; the effect upon the surrounding neighborhood; the compliance of the request with all applicable City ordinances and the Orem General Plan, and the special conditions applicable to the request.

BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF OREM, UTAH, as follows:

- 1. The Planning Commission finds this request will not negatively affect the health, safety, and general welfare of the City.
- 2. The Planning Commission hereby approves the site plan of Holiday Oil located generally at 1981 South Geneva Road in the C2 zone, as shown in Exhibit "A" which is attached hereto and incorporated herein by reference with the following conditions:
  - a. That the parking lot lights be turned off at midnight;
  - b. That the fuel canopy lights be reduced to every other light during the hours of midnight to 5:00 a.m.; and
  - c. That the pole lights be shielded with shields at least 6 inches on three sides (back

and sides) from adjacent residential properties.

- 3. This resolution shall take effect immediately upon passage.
- 4. If any part of this resolution shall be declared invalid, such decision shall not affect the validity of the remainder of this resolution.
- 5. All other resolutions or policies in conflict herewith, either in whole or part, are hereby repealed.






