**OAM2023-001051** – Proposed amendment to the White City Subdivision Ordinance, Title 18 of the White City Municipal Code, to comply with review timeframes, review cycle limits, land use authority designations and other amendments mandated by SB 174. **Planner:** Brian Tucker (Motion/Voting)

*Greater Salt Lake Municipal Services District Planning Manager Brian Tucker and Counsel Jay Springer provided an analysis of the code amendments.*

*Commissioners, staff, and Counsel had a brief discussion regarding administrative land use authority designation, command planning commission being the Administrative Land Use Authority, curved authority with staff, planning commission, and Council. Planning Commission the authority even for the smaller lots, five lots being state code and could be changed from 10 or less, consider two lots, 18.08.010A change to administrator is designee of two or fewer lots and 18.08.010B changed to planning commission is authority of three or greater lots.
