



TOQUERVILLE CITY COUNCIL

Special City Council Meeting Minutes March 6, 2024, at 5:00 pm 212 N. Toquer Blvd, Toquerville Utah

Present: Mayor Justin Sip; Councilmembers: Gary Chaves, Chuck Williams, Todd Sands, Wayne Olsen, Joey Campbell; Staff: City Manager Afton Moore, City Recorder Daisy Fuentes, Planning and Zoning Administrator Darrin LeFevre, City Attorney Matt Ekins.

A. CALL TO ORDER:

Mayor Sip called the meeting to order at 5:03 p.m. The pledge of allegiance was led by Councilman Olsen and the invocation was led by Councilman Sands.

Councilman Campbell is attending via phone call.

B. APPROVAL OF AGENDA:

Councilman Sands made a motion to move approve the agenda order. Councilman Williams seconded the motion. Motion carried 4-0. Chuck Williams – aye, Joey Campbell – aye, Todd Sands – aye, Wayne Olsen – aye;

Councilman Sands created a motion to approve business item 8 with changes in xiii, roman numeral 13, that we add to a permanent erosion control plan addressing the final conditions o the site that we instruct the city to come up with a policy for that in accordance to the current maintenance policy and then that we also change under exemption B, number 2, that we change the residential landscape to mirror the agricultural number 1 and then also that we include all the recommended changes to the ordinance that the Planning Commission recommended and eliminate exemption B – strike the sentence the applicability of any of the below listed exemptions must be determined by the zoning administrator.

Councilman Williams seconded the motion. Motion carried 3-2. Gary Chaves – aye, Chuck Williams – aye, Joey Campbell – nay, Todd Sands – aye, Wayne Olsen – nay;
