Ordinance No. PZ-24M

*AN ORDINANCE OF THE TOWN OF VIRGIN, UTAH, ADOPTING THE **VIRGIN, UTAH - MASTER TRANSPORTATION PLAN – AUGUST 2023 (UDOT)** WITH THE EXCEPTIONS OF FIGURES 6, 11, 12, 13 AND 15; AND **TABLE 6 -ITEMS 6, 7, 8, 9, 13, AND 14 (ONLY)**; WHICH EXCEPTIONS SHALL REFLECT THE CONTENT OF THE TOWN’S (NEW) GENERAL PLAN (CURRENTLY IN PROGRESS) BEFORE ADOPTION.*

WHEREAS pursuant to Utah Code Ann. § 10-1-201 Virgin Town (“the Town”) is a Utah municipal corporation and political subdivision of the State of Utah;

WHEREAS pursuant to Utah Code Ann. § 10-3b-401 the Virgin Town Council (“Town Council”) is the legislative and governing body of the Town;

WHEREAS pursuant to Utah Code Ann. § 10-9a-103(30) the Town Council, in addition to being the legislative and governing body of the Town, is also the Land Use Authority vested with power to enact all Land Use Regulations and make all Land Use Decisions within the Town, unless the latter administrative power is delegated to another body or person;

WHEREAS the Town has begun work on a New General Plan;

WHEREAS the Town finds it necessary to adopt a Master Transportation Plan;

WHEREAS the Planning & Zoning Commission has reviewed the **VIRGIN, UTAH - MASTER TRANSPORTATION PLAN – AUGUST 2023 (UDOT)** and finds it, and other UDOT resources as having potential benefit toward the safety, planning, and proper development of the Town;

WHEREAS the components of a Master Transportation Plan, both binding and non-binding, should most properly, accurately reflect the Town’s General Plan and vice versa;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF VIRGIN, UTAH:

Ordinance

1. That the Town Council of Virgin, as Land Use Authority shall hereby adopt the **VIRGIN, UTAH - MASTER TRANSPORTATION PLAN – AUGUST 2023 (UDOT)**,

- A. As a guiding recommendation for and to be included in the Town’s (new) General Plan where applicable and as needed; and
- B. With exception of ALL the following:
 - 1) *All of FIGURES 6, 11, 12, 13 and 15, and any representations of the same throughout; and*
 - 2) *Table 6- items numbered 6, 7, 8, 9, 13, and 14, and any representations of the same throughout; and*
 - a. Excepted items may only to be adopted when revised to accurately reflect the Towns (New) General Plan, currently in progress; and
- C. As it is included, herein, with redactions, and as “Attachment 1” of this ordinance.

2. Severability. If any section, clause or portion of this Ordinance is declared invalid by a court of competent jurisdiction, the remainder shall not be affected thereby and shall remain in full force and effect.

4. Conflicts/Repeater. This Ordinance repeals and supersedes the provisions of any prior ordinance in conflict herewith.

5. Effective Date. This Ordinance shall become effective immediately upon adoption by the Virgin Town Council and execution by the Virgin Town Mayor.
