SUBJECT: Consider **Ordinance No. 2024-O-05** Approving Amendments to Chapter 9.32.090 of the Midvale Municipal Code Regarding Alcoholic Beverages in Public Parks and Public Places.

SUMMARY:

On March 16, 2024, City Council held a discussion regarding proposed amendments to Chapter 9.32.090. On March 26, 2024, city staff brought back these proposed amendments to City Council for adoption. These amendments modify existing regulations concerning the consumption of alcoholic beverages in public parks and public places. The proposed amendment provides a framework for allowing alcohol consumption in public parks and public places under the following conditions and requirements:

1. **Approved Site Plan Requirement:** The proposed amendment allows the consumption and possession of alcoholic beverages in specified public areas if the location is included in an approved site plan filed with the City by a licensee.
2. **Compliance with State and Local Regulations:** The amendment specifies that any licensee wishing to allow alcohol consumption must adhere to all state and local regulations related to the sale and distribution of alcoholic beverages.

Upon further discussion by the Council, it was moved to table this item with a request for staff to bring back this same proposed amendment along with an alternate amendment that would remove Public Parks as an allowable place for the consumption of alcohol.

The catalyst for this code amendment includes the recent ability for restaurant and entertainment businesses on Midvale Main to enter use agreements for the use of bulb outs and other publicly owned property on Midvale Main to enable outdoor dining. This amendment would allow those businesses with appropriate liquor licenses to serve alcohol in these leased areas. Additionally, it will provide the opportunity for events to host beer gardens or other related activities. This will be pivotal in activating Midvale Main and other Midvale locations through events, creating a controlled environment for the consumption of alcohol when appropriate.

City staff believes that the proposed code amendment allowing for alcohol consumption in public parks and public spaces can help to activate city-owned spaces as well as to establish Midvale City as a destination for increased festivals and fairs, in which the community can enjoy. Many festivals ranging from the Salt Lake City Living Traditions Festival, Ogden Twilight Concert Series, Park City Arts Festival, and Moab Music Festival have historically offered the ability to consume alcohol within a controlled environment. This ability is believed to provide an added experience for patrons and can be a significant draw for increased participation. Midvale City has always celebrated its diversity and welcomes a variety of cultural events. This amendment would provide the option to provide this added experience that enhances these events in a way for all to enjoy.

ORDINANCE NO. 2024-O-05

AN ORDINANCE AMENDING MIDVALE MUNICIPAL CODE SECTION 9.32.090 ALCOHOLIC BEVERAGES IN PUBLIC PARKS AND PUBLIC PLACES.

WHEREAS, as authorized by Utah Code Ann. § 10-8-84, the City Council is authorized to "pass all ordinances and rules, and make all regulations, not repugnant to law, [...] as are necessary and proper to provide for the safety and preserve the health, and promote the prosperity, improve the morals, peace and good order, comfort, and convenience of the city and its inhabitants, and for the protection of property in the city"; and

WHEREAS, as authorized by Utah Code Ann. § 32B-1-204, the City Council is "expressly granted regulatory authority to regulate" issues related to alcoholic product control as provided by Title 32B and, if Title 32B "does not expressly address an issue related to alcoholic product control, a local authority may regulate that issue if the regulation: (a) is of the sale, offer for sale, furnishing, or consumption of an alcoholic product; and (b) does not conflict with [Title 32B]"; and

WHEREAS, Utah Code Ann. Title 32B requires a person to receive written consent of the City prior to applying for an alcohol license with the Department of Alcohol Beverage Services; and

WHEREAS, Utah Code Ann. § 32B-4-421 prohibits a person from "consum[ing] liquor in a public building, park, or stadium, except as provided by [Title 32B]"; and

WHEREAS, as authorized by Utah Code Ann. § 10-8-11, the City Council is authorized to "regulate the use of use of streets, alleys, avenues, sidewalks, crosswalks, parks, and public grounds;" and

WHEREAS, the City Council regulates the sale, manufacture, wholesaling, and warehousing of alcoholic beverages within Midvale City pursuant to Midvale Municipal Code 5.10.030; and

WHEREAS, Midvale Municipal Code 9.32.090 currently prohibits the consumption and possession of any alcoholic beverage in any public park, public place, public building, stadium, street, alley, sidewalk, and roadway; and

WHEREAS, the City Council desires to activate Midvale Main Street by encouraging restaurants, outdoor dining, community events and festivals, and other activities that will draw residents, businesses, and visitors to Midvale Main Street; and

WHEREAS, the City Council already permits the use of public spaces along Midvale Main Street for outdoor dining and community events and festivals if the applicant has the appropriate permissions, agreements, and licenses; and

WHEREAS, the City Council believes that allowing the sale and consumption of alcohol in public spaces, when properly permitted and regulated, will further encourage the activation of Midvale Main Street; and

WHEREAS, the City Council desires that any sale or consumption of alcohol in a public place be appropriately regulated and overseen by the City and the Department of Alcohol Beverage Services; and

WHEREAS, the City Council desires to provide for similar opportunities to use public places for the sale and consumption of alcohol throughout the City as such opportunities potentially become available in the future and with similar requirements for permissions, agreements, and licenses; and

WHEREAS, based on the forgoing, the City Council finds it is appropriate and within the best interest of the City to amend the Code to permit the consumption of alcohol in public parks and public places under limited circumstances and with appropriate oversight and regulation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Midvale City, Utah as follows:

Section 1. The City Council desires to amend Midvale Municipal Code Chapter 9.32.090 as set forth in Exhibit A.

Section 2. A violation of this ordinance includes the possibility of fines or imprisonment. Midvale City is required, under Utah Code Annotated Section 78B-22-301, to provide for indigent legal defense, as that term is defined in Utah Code Annotated Section 78B-22-102.

Section 3. This ordinance is effective upon publication in accordance with Section 10-3-711 of the Utah Code.

SUBJECT: Discuss Midvale City's Position Regarding A Ceasefire in Israel-Gaza Crisis

SUMMARY:

On March 26, 2024, Midvale residents attended the Midvale City Council meeting and spoke during public comments regarding their desire for the City Council to approve a resolution supporting a ceasefire in the Israel-Gaza Crisis. In response to this request, the City Council agreed to discuss a ceasefire resolution during the April 2, 2024 City Council Meeting.

Staff is working to prepare a draft resolution for the City Council that will be used to facilitate the discussion during the meeting. Based on the feedback provided by the City Council, a final version will be prepared for approval during a future City Council meeting.
