**1. Approval of Minutes:** February 2024, motion made to approve by Wayne Paul, seconded by Les Thompson. **Motion Approved.** 

## 2. Discuss Reports of the Following:

- a. BLM- Jaydon reported work on the parking lot at New Joe's. Also new Spanish Trail signs have been put in, as well as a new OHV heritage kiosk at the corrals off HWY 6 to inform people of the app they can use for self-guided tours. Coming up this week will be some San Rafael Advisory meetings including a field trip, and a morning meeting. Spring season amps up in March and rangers will be returning. Trail cat days are planned for next week in conjunction with the state to put on some training, mostly for BLM staff. The Behind the Reef Trail and a few side trails will be worked on. Travel management plan will be releasing the alternatives and preliminary drafts to the public on Feb 2. Will continue to work with cooperating agencies to address some issues, including the interactive map. Working on a map that will better represent closures as well as trails that are open and will be opened in the different alternatives. Discussion on map quality for the public and some of the alternative plans reopening trails that are currently closed. Discussion on upcoming SUWA work and where they will be starting to work. Watermelon Crawl coming up soon in Green River as well as Green River Rocks and Easter weekend.
- **b. Forest Service** Lots of snow up on the mountain, hoping to get access soon to shovel out parking lots and bathrooms. Avalanche danger has been extremely high, use caution and stay away from the high angles. Putting together a reproduction of a map from 1991 showing winter use for motorized/non areas. Now responding to comments on Little's Creek mountain bike trails project, no major issues. Looking to make a decision on that project soon. Also responding to and reviewing questions and comments about the Forest Plan Revision, most having to do with ROS. Otherwise just planning and hiring for the summer. Discussion on different trails that need to be groomed this summer.
