Fire Chief Montoya stated the car has been retired and it has transmission issues, he would like to surplus it. Council Member Chavez asked if Fire Chief Montoya was going to handle the surplus, Fire Chief Montoya stated the City handles all of that. Council Member Stapley asked if there was a replacement for this vehicle, Fire Chief Montoya stated there is a replacement.

Discussion and possible approval of the Fire Department Reserve Program.

Fire Chief Montoya stated that they are having a hard time finding, and keeping people other departments have offered to help. Assistant Fire Chief Wise stated that they have been discussing for two years, a way to get more reserves on staff to help. He stated we are currently at 14 volunteers, 4 of them are going through fire fighter 1 & 2, one finishing the EMT program. Helper City is the only agency in the County that responds as a licensed EMS agency through the state, Helper has to have the EMT requirements. Assistant Chief Wise stated in order to get the stipend he is proposing, volunteers would need to respond to a minimum of 5 calls a month. Daytime coverage is the biggest problem to cover, one stipulation they are proposing is they do not need to live in Helper, they would have to live in Carbon County, and they would like someone who frequents Helper. This is not a full solution, it would support for the

Department. This would be for medical calls, as Helper Fire responds to every medical that the ambulance responds to, in their 1800 square mile response area. Council Member Stapley stated in the proposal they are seeking individuals with Firefighter 1, or EMT, he asked if they were targeting certified individuals only, Fire Chief Montoya stated they must be certified for liability reasons. Assistant Fire Chief Wise stated they would like individuals who are wildfire trained, Council Member Dornan asked if it was a monthly stipend or per event, Fire Chief Montoya stated it would be monthly. Assistant Fire Chief Wise stated it would be \$50.00, for a minimum of 5 calls.

Discussion on the diversion for the Gay Ditch.

Mayor Peterman asked Joe Sacco to speak about the Gay Ditch. Joe Sacco stated that since the River Restoration 5 years ago, he has not been able to get water, he stated in the last 5 years they have lost about \$40,000 in crops. He stated something needs to be done, he stated the only person that is willing to help is Dave Meyer. Joe Sacco stated that Dave Meyer suggested putting a pipe further out in the river, when they did the diversion damn it created an eddy, and it silts his head gate. Joe Sacco stated it has been 5 years without the appropriate amount of water, and it is time something is done to remedy that. Mayor Peterman stated when Joe Sacco indicated he had no water, she tried to remedy the problem by calling Dave Meyer, or having Helper City Public Works go out and help clear the problem and make sure he can get his water. Joe Sacco stated he is only getting a foot and a half of water, he is entitled to 11 ½ feet of water there. Joe Sacco stated that the diversion damn has washed out again, so there is nothing with enough force to push the water through the pipe. Mayor Peterman would like to get with Dave Meyer and Joe Sacco next week and come up with a solution.

Discussion and possible approval of Resolution 2024-01 a resolution of the Municipal Building Authority of Helper City, Utah, calling a public hearing and authorizing notice of intention to issue not more than \$800,000 of taxable lease revenue bonds for the acquisition of a public works building, and related improvements; fixing the maximum interest rate, maturity and discount of the bonds; and related matters.

Mayor Peterman stated that council needed to convene as the Municipal Building Authority of Helper City, Utah.

Mayor Peterman stated Helper City's Public Safety Building which is also a CIB loan/grant is coming due, so we will pay that off, which will lower our debt. We will save about \$18,000 dollars a year and get a new building in the process.
