We need better signage to market our business on Main Street. We anticipate the signage to cost around \$1,000. We would want to utilize the remainder of the grant (\$9,000) to assist with hiring and onboarding at least three part-time employees.

Desert Flora is located inside The Art Grove (another business that I Co-Own) and increasing the signage and hiring these employees would allow all of the businesses within The Art Grove to grow. We would be able to expand our daily hours, offer more services, and bring in additional businesses to work with our small business collective.

Project Description

We will be using the grant to update the electrical infrastructure for the building located on 7 North Main St. This is a necessary upgrade because the current infrastructure will not support commercial equipment. We will need to add a 3-phase electrical panel on the exterior of the building and an additional panel inside the building, running about \$10,000.00 in supplies and labor fees from the electricians, which is expected to be in the range of \$3,000.00 - \$5,000.00. Upon completion of this project, the downtown building will be a proper commercial building supplied with the correct electrical system, which can support more production and growth by accommodating more equipment. Upgrading will also provide the county with another viable business location, be safer, and serve as a gateway to future expansion.

Good Paying Jobs

DD&P is projecting to create up to 4 -5 jobs within its first year open to the public. The electrical infrastructure update project directly contributes to the creation of those jobs because the grant will be used to update the building's electrical system, allowing us to open it to the public. Other benefits to Tooele County provided by updating the building include: - Creating a more family-friendly environment, compared to the location previously being a tattoo shop with limited customer access, the bakery will have a diversity of customers. -A local bakery for Tooele residents, who otherwise have to commute outside the city.

Increase Household Incomes

DD&P will increase household income by providing jobs, allowing more members of Tooele County to earn income. Additionally, there will be opportunities for advancement, with the chance to become managers and earn higher wages. Providing local employment opportunities will not only enhance our

Project Description

We are working to reformulate 10 Auminay Naturals products to level up clean ingredients, which will open more doors with influencers and provide the opportunity to present this product line to Natural Grocers (168 stores nation-wide). We will also re-approach Harmons, who discontinued our brand in their stores during the pandemic as everything shut down. With this reformulation project, we will focus on sustainability by choosing eco-friendly packaging, which is important to many customers in the natural channel.

Explain how this project helps within Tooele County to:

1. Add good-paying jobs:

As we stabilize from economic downturns that affected us in 2023, we will be building a new sales team of four new employees, with opportunities to increase their earnings through education and customer care. This will allow Melanie to shift focus to production as we reformulate and pursue wholesale distribution channels. We will also begin implementing a marketing team, beginning with a Market Expansion Specialist who will be focused on community outreach, promoting Auminay, and reactivation campaigns. Finally, as we grow our wholesale distribution channel, we will hire a Production Manager and additional production helpers as needed (at least one in 2024).

2. Increase household incomes:

Project Description

This is The Driving School. We would like to apply for the grants being offered by the city. We have been a business in the city for over 20 years; we having bought the business at the end of 2018, beginning of 2019. We feel that we provide a very necessary service for the people of Tooele and surrounding areas. The school system Driver's education classes are severely backed up and struggling to get students through in a timely manner. We are able to provide this service in a timely manner, and pride ourselves on our work ethic, and in providing a quality education that prepares our students to be good drivers in our community. We have a need to keep our vehicles updated and in good condition, which is obviously a high priority. We would like to retire one of our vehicles and replace it with a newer, more reliable one. We also have a couple of computers that need to be upgraded. Receiving this grant would help us greatly in being able to do those things. We appreciate your consideration, and we value our place in the community. We look forward to many more years of service for the people of Tooele. The Driving School can receive about 30 students per month during the winter months (about \$10,000 gross sales and after gas, insurance, and payroll about \$3,000 net), but during the summer months we can receive double to triple the amount of students who have to wait 4-8 weeks to receive in-vehicle training because of limited instructors and vehicles. With the grant and purchase of an additional vehicle we can have 2-3 additional instructors, maintain higher students quickly, and then carry the higher volume into the school months where student can finish driving instruction within weeks and not months. We would anticipate at least double the students a year from now if we can accommodate the quicker training time.

Good Paying Jobs

We are looking to hire 2-3 part-time employees to be instructors to new driving students - both in the vehicle instruction and classroom instruction. One additional vehicle will allow us to hire the part-time employees so we can more than one or two instructors teaching students at the same

time. Summer time is extremely busy and we just do not have enough vehicles to get student through quickly.

Increase Household Incomes

With 2-3 part time employees we offer \$12 an hour for training, then \$15 an hour when fully trained to teach driving students. Part-time instructors can work as needed in the evening and weekends up to 15 to 25 hours as an additional income.

Project Description

When Tooele Valley Bicycle (TVB) opened its retail location in 2019, we had planned to primarily service and sell mountain bikes, road bikes, and kids' bikes. While Aaron and Jarom are both skilled and experienced bicycle technicians, we quickly found a couple of service areas where we would benefit from additional training, skills and tools. The first service area pertains to the electrical systems found on many e-bikes. Along with many shops in our industry, we were surprised by the growing demand for e-bikes. As the cost of fuel has risen, more and more people are using e-bikes and e-scooters instead of cars to run errands or even commute. As part of this project, we plan to increase our inventory of urban/commuter e-bikes. As surprised as we were with e-bike demand, we were even more surprised and unprepared for the types of service and maintenance these bikes require. They may need software updates or replacement of displays, motors, control boxes, pedal assist sensors, wiring, etc. The skills to work on these parts are not taught in any bicycle repair course. Support to do these repairs can sometimes be found by reaching out to the manufacturer, but the process to diagnose which part to replace can be time consuming and frustrating. There are also other micro mobility devices such as electric scooters and one wheels that operate with systems very similar to many e-bikes. Our customers have begun asking us to diagnose issues on these devices as well. We realized that there is an opportunity for us to provide a service that is difficult to obtain as very few bike shops or other service shops will work on these items. For some shops, they will not service any brands they do sell. Others are concerned about safety issues. Most have well-trained technicians who do great work on bike parts but lack training on the electronic parts of e-bikes. We would like to change that at our shop. In order to do so, we need technicians who are familiar with the inner workings of mobility devices using brushless motor systems, who know how to utilize diagnostic tools to identify electronic problems in the devices, and who know how to replace damaged parts properly and safely. We have recently done some introductory training through the Canadian Electric Bike Association (CEBA), but we believe additional training along with the correct tools is necessary for us to provide service at the level and quality we expect of our shop. The Light Electric Vehicle Association (LEVA) offers a more extensive four-level technician training that is specific to electric bikes and micro mobility devices. We plan to have two technicians to complete this training and become certified at all four levels. Suspension service is the second area we would like to grow the service offerings in our shop. Jarom attended

suspension training at United Bicycle Institute and is a certified suspension technician. However, due to the lack of certain specialized tools, we still find these services to be less efficient and less profitable than they could be. We plan to add a mobile suspension workstation with specialized suspension tools to the shop. This station will be pulled out and used for suspension jobs making this work more efficient and profitable than we are currently able to do it.

Good Paying Jobs

This project will provide TVB the means to train our technicians in skills beyond that of the standard bicycle mechanic. Technicians with the ability to diagnose and repair many of the e-bikes and micromobility devices and technicians with the skills to perform suspension work are of greater value to employers and will earn a higher wage. We anticipate TVB's increased ability to perform repairs on e-bikes, micro mobility devices and bike suspension systems will necessitate we hire and train more technicians who will be paid good and fair wages.

Increase Household Incomes

As TVB's technicians gain additional technical skills, their wages will increase and be commensurate with their abilities. This will lead to an increase in the households of our technicians.
