Mayor Ken Phippen called the meeting order.

a. Introduction of Madison Aviles, she presented the Wasatch Front Regional Council Local Administrative Advisor Program.

\#4 - Business Items
a. Consider approval of business license - Trugreen Limited Partnership Solicitors License

Sara Ford Was present requesting a solicitor's license for Trugreen.
Bob Blind asked if chemicals would be stored in Farr West. And if the employee that has a criminal record would be supervised.
Katie Williams said that she was uncomfortable with approving the employee that had a criminal record. Katie also stated that the hour of solicitation is prohibited from $8: 00 \mathrm{pm}$ to 9:00am.
Ken Phippen wants to ensure that if any home has a no soliciting sign on the home, they do not bother them.
Liam Keough stated that you could approve all the licenses but exclude the one with a criminal record.
Sara Ford said that it was due to a DUI and the employee in recovery and has a breath device in his car. She also stated that the chemicals are not stored in Farr West until they have a job that requires them.

c. Consider approval of Resolution No. 2024-02, approving the Municipal Wastewater Planning Survey

David Bunderson is present.
Katie Williams asked if we should find funding for updating to update the capital facilities plans. Wants to know what the strategy is going to be for the capital expenditures. Katie asked about the emergency preparedness plan referenced in the audit and asked if it would be an appropriate task to ask C.E.R.T. to manage.
David Bunderson stated that we have a protocol for emergencies, but we must take them as we come because every situation is different. But an emergency plan would be beneficial Cody Cardon said that if we are reviewing our rate and making a profit and funding our deprecation, we should have some money set aside for the pipe replacement.
Tim Shupe said that he would rather have an overestimate, so we have the funds.
Bob Blind said he would like to involve C.E.R.T. in developing an emergency preparedness plan for the municipal wastewater.

BOB BLIND MOTIONED TO APPROVE RESOLUTION NO. 2024-02, APPROVING THE MUNICIPAL WASTEWATER PLANNING SURVEY. TIM SHUPE SECONDED THE MOTION. A ROLL CALL VOTE WAS TAKEN WITH DAVID JAY, BOB BLIND, KATIE WILLIAMS AND TIM SHUPE ALL VOTING AYE. MOTION PASSES UNANIMOUSLY.
c. Consider approval of Resolution No. 2024-03, approving the Farr West City Website Privacy Policy

Liam Keogh said the State of Utah is auditing cities on their website privacy policies. He explained that we need to be compliant with the state to protect the city from liability should any personal information be collected on the city website.
Bob Blind wants to protect ourselves from any personal information leaking if we come across that kind of information on our website.

David Jay reported that he went to 2 meetings regarding potential developments and met with Roberta Hudson in the Senior Center to discuss if they need anything.

Bob Blind reported on the Central Weber Sewer System and C.E.R.T. He stated they ratified vouchers for the sewer district. He is trying to reach out to the churches regarding the block captain program not working well. He wants to work on a Rapid Damage Assessment Program where the first people that come to Farr West City office in an emergency will get instructions on what to do. He stated there is a budget request coming for the C.E.R.T. program regarding some equipment for the Rapid Damage Assessment Program.

Katie Williams reported that at the Parks meeting they talked about a disc golf course at the city offices and funding it independently so there would be no cost to the city. Lyle has gotten bids on playgrounds. Katie will be submitting two R.A.M.P. applications for the Farr West Park baseball dugouts and the prizes for the Freedom Festival.

Ken Phippen reported on Weber Human Services regarding senior centers and stated they want cities to pay a cost because some of our residents go to other senior centers.
