



## NOTICE OF PUBLIC HEARING

### KEARNS PLANNING COMMISSION

NOTICE IS HEREBY GIVEN Pursuant to Utah Code Title 10, Chapter 9a, Section 205, that the Kearns Planning Commission (the “Commission”) will hold a public hearing on Monday, May 6, 2024, beginning at 5:30 PM (Meeting location on the back page). The purpose of the hearing is to receive public comments regarding:

- **OAM2024-001140 - Miscellaneous Amendments to Titles 18 and 19 of Kearns Code:** Staff are bringing forth several proposed amendments for Planning Commission consideration. These proposed revisions are intended to clarify language, remove language inconsistencies, and address any other conflicts that have arisen during the application of the ordinance. Staff will give a brief presentation to the Commission prior to opening the public hearing. Following the public hearing, the Commission may make a recommendation to the Council regarding the changes. **Planner:** Kayla Mauldin
- **OAM2024-001135 – Proposed amendments to Section 19.28.060 “Lot Coverage” in single family residential zones and Section 19.48.040 “Standards for Parking in R-1 and R-2 Residential Zones” to consider modifications to the maximum amount of impervious surface allowed in front yards and to clarify the standards for parking motor vehicles and recreational vehicles in residential areas of Kearns. **Planner:** Curtis Woodward**
