ORDINANCE NO. 2024-8: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING THE OGDEN MUNICIPAL CODE BY ADOPTING SUBSECTION 15-17-4.I TO REVISE PAINTING OF EXTERIOR BRICK REGULATIONS IN THE R-3 ZONE; ADOPTING SUBSECTION 15-18-4.I REVISING PAINTING OF EXTERIOR BRICK RESTRICTIONS IN THE R-4 ZONE; AMENDING TITLE 15, CHAPTER 32 BY ADOPTING A NEW SECTION 7 TO REVISE PAINTING OF EXTERIOR BRICK REGULATIONS IN THE R-MFV AND R-MFH ZONES; AMENDING SUBSECTION 15-33-5.A REVISING PAINTING OF EXTERIOR BRICK REGULATIONS IN THE PI ZONE; AMENDING TITLE 15, CHAPTER 34 BY ADOPTING A NEW SECTION 10 TO PROHIBIT PAINTING OR COVERING EXTERIOR BRICK IN DOWNTOWN COMMERCIAL ZONES; AMENDING SUBSECTION 15-37-5.A REVISING PAINTING OF EXTERIOR BRICK REGULATIONS IN THE R-9 ZONE; AMENDING SUBSECTION 15-41-5.F REVISING PAINTING OF EXTERIOR BRICK REGULATIONS IN THE NC ZONE; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE NO. 2024-9: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING THE OGDEN MUNICIPAL CODE BY AMENDING CHAPTER 3-31 TO REVISE THE ORGANIZATION AND NAME OF THE OGDEN NATURAL RESOURCES AND SUSTAINABILITY STEWARDSHIP COMMITTEE; TO MAKE TECHNICAL CHANGES; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.
