$>$ 2024-2025 Teacher Student Success Act Plan - Ryan Robinson gave a brief history of the TSSA Plan since its inception in 2019. It is a continuous improvement plan that consists of two goals and a budget to help support the goals. It is also tied to a measurement with the standardized end of year test scores in math and language arts. We approve the plan every year with minor changes usually due to state requests.
