Parker Byington Culinary Water Contract

Parker Byington is in attendance to talk about the water given to him for the trial run by the city for his test run for any future use. Parker states the usage is consistent with the 18,000 gallons per day he planned on using. Jed Hansen the Gunnison Valley Fire Chief is also in attendance to give some interesting information on the ISO rating. Jed states the City is going to be just fine with the ratings he is receiving from the flow testing. Jed wants it known that if townhomes are ever put in the city, a higher fire flow will be necessary.

Councilman Fisher made a motion to grant Heritage Heights Dairy with a 3 month contract which will be revisited on July 17th. If at any time the city might need that water Parker will be given a 4 hours notice before the water will be turned off. Seconded by Councilman Christensen. Carries 5-0.

Irrigation Meter Discussion

The company Centerfield wanted to go with has gone out of business. City needs to decide if they would like to move forward without the automatic shut off valve. Thought has been that maybe the city purchases 20-40 shut off valves and they get installed and ultimately paid for by the residents who abuse their water right.

Another decision needs to be made if a radio tower or cellular station will be used. A public hearing will be scheduled for April 17, 2024 to inform the residents and get the information out.

Employee Raise for Certification

Mayor Leatherwood would like to give Jonah a \$1 per hour raise for obtaining his culinary water operator certification previously discussed by the council when hiring him.
