Multicultural Affairs Updates - MCA team

• Magnify Utah was announced at the One Utah Summit. This is a learning and resource hub that connects community, places and stories across Utah. We recently held the Ogden Mural Unveiling for youth who are system-involved to show community partners the mural that the youth created together. This program has momentum to continue and several commission members expressed interest in helping with mentorship for the next iteration. The Men of Hope program has begun at the Juvenile Justice Youth Services, this will be a several week mentoring program that teaches healthy communication, leadership, and civic engagement. We also met with Roots Charter School, which is a school that combines education with practical application like agriculture, animal husbandry, and horticulture.
