RESOLUTION REGARDING ZAP TAX

RESOLUTION NO. 2024-05

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HELPER, CARBON COUNTY, UTAH, AUTHORIZING THE PROCESSES AND PROCEDURES NECESSARY AND HELPFUL TO PREPARE FOR VOTER APPROVAL TO REAUTHORIZE THE RAP TAX FOR HELPER CITY; AND RELATED MATTERS.

WHEREAS, in 2013 the City of Helper, Carbon County, Utah (the "City") presented a ballot proposition to the voters of the City and by majority vote they reapproved a tax under Title 59, Part 12, Chapter 14 of the Utah Code for Arts, Botanical, Cultural, Recreational, and Zoological Tax (RAP Tax), which was imposed in 2014; and

WHEREAS, the City desires to authorize the processes and procedures to reauthorize the RAP Tax in 2024 by calling an election on the matter; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HELPER, CARBON COUNTY, UTAH AS FOLLOWS:

Section 1. The City Council hereby authorizes all actions necessary and helpful to call an election and place on the ballot to reauthorize the RAP Tax under Title 59, Part 12, Chapter 7 of the Utah Code and City officers, employees and agents are directed to take all actions necessary or helpful to accomplish the same, including preparing and posting notices, information pamphlets, and all other documents or certificates.

Section 2. The City hereby ratifies, approves and confirms all actions already taken by the City or its agents related to the RAP Tax.

Section 3. The City is to deliver to the Carbon County Board of County Commissioners the following documents (1) a Notice of Intention of Helper City, which is hereby authorized, to submit the ballot question related to the RAP Tax to the voters of the City; (2) Termination of any Interlocal Agreements between the City and County, and (3) Proposed Resolution to Carbon County indicating it does not intend to pursue enactment and imposition of a county wide RAP Tax under Title 59, Part 12, Chapter 14 of the Utah Code.


Section 4. The appropriate officers and agents of the City are authorized to take all action necessary or reasonably required to carry out, give effect to and consummate the transaction contemplated hereby, including, without limitation, the execution and delivery of a ballot proposition to be delivered to the Lt. Governor.

Section 5. All regulations, orders and resolutions of the City or parts thereof inconsistent herewith are hereby repealed to the extent only of such inconsistency. This

repealer shall not be construed as reviving any regulation, order, resolution or ordinance or part thereof.

Section 6. This Resolution shall become effective immediately upon adoption by the City Council of the City.




