#### HB 461 - Child Care Grant Amendments Update

#### **CCDF Federal Regulations**

§ 98.20 A child's eligibility for child care services

(a) To be eligible for services under <u>§ 98.50</u>, a child shall, at the time of eligibility determination or redetermination:

(2)

(i) Reside with a family whose income does not exceed 85 percent of the State's median income (SMI), which must be based on the most recent SMI data that is published by the Bureau of the Census, for a family of the same size; and

(ii) Whose family assets do not exceed \$1,000,000 (as certified by such family member); and

(3)

(i) Reside with a parent or parents who are working or attending a job training or educational program; or

(ii) Receive, or need to receive, protective services, which may include specific populations of vulnerable children as identified by the Lead Agency, and reside with a parent or parents other than the parent(s) described in <u>paragraph (a)(3)(i)</u> of this section.

(A) At grantee option, the requirements in <u>paragraph (a)(2)</u> of this section may be waived for families eligible for child care pursuant to this paragraph, if determined to be necessary on a case-by-case basis.





### **DWS Provider Portal**

- NEW DWS Provider Portal coming on July 1
  - Training and resources will be available in June.
  - Easy to navigate
  - Compatible with more devices
- Same features as current portal



### **DWS Administrative Rule Changes**

### Highlights

- Monthly certification in the DWS Provider Portal will start on the 20th of the month.
- Ineligibility for OCC grants for non-repayment of adjudicated overpayments
- A center director may be eligible for child care as long as they do not have a financial interest in the center.
- Clarifications and updates around 12-month eligibility for customers
  - Proposed rules will go out for public comment once draft is finalized.
  - Implementation date pending (possibly August or September).
  - DWS Provider Guide will be updated and published online 30 days in advance of rule changes.

# **Professional Activity** Updates

### Coaching

"Attend a coaching feedback session hosted by an external, professional coach with subject matter expertise, who provides individual coaching feedback relevant to the youth or early childhood education field during times when staff are not responsible for children/youth care. Internal coaches participating in the OCC Becoming High Quality or Expanded Student Access grants, during the term of the grant also qualify."

#### **Documentation:**

"Only individual coaching feedback time may be counted. (Not observation or modeling time). Submit a certificate from the outside host agency/organization or from the internal coach participating in a qualifying OCC grant to confirm proof of participation. Documentation must include your name, the coach's name, title, their employer/organization and credentials, the signature of the mentor coach (if applicable), the coaching feedback topic, date and number of hours awarded."

### **CCQS Cohort Meetings**

"Attend CCQS Cohort Meetings hosted by a CAC CCQS Specialist who is an approved Specialty Instructor."

#### Documentation:

"Only time spent in CCQS Cohort Meetings may be counted. (Training hours are counted separately). Submit a certificate from CAC to confirm proof of participation. Documentation must include your name, the Specialist's name, their employer/organization, date(s) and number of hours awarded."

### **School Readiness**

- Board approved funding for all current ESA grantees that met the scoring threshold to include all additional costs and asked that the eligible seats be reduced to accommodate for budget limitations.
  - Expanded Student Access (ESA)
    - **\$10,492,359**
    - Reduced eligible seats by 18%
  - Becoming High Quality
    - \$1,440,000
    - Continuation of funding for all grantees on multi-year grants.
- Board voted to cancel scheduled 6/26/2024 meeting and will not be meeting again.



- Current grant recipients will receive their monthly grant at the current rate of 50% of the full grant amount for July and August 2024.
- There is a possibility, depending on funding availability, that a smaller reduced payment could be issued in September 2024.
- Reported enrollment to capacity continues to be around 80-81%.
- Since last Advisory, Stabilization Grants closed for five programs, three of which sold their business.

### USBE Updates--CACFP

- New Meal Plan Published on April 25th
  - Child Nutrition Programs: <u>Meal Patterns Consistent with the</u> <u>2020-2025 Dietary Guidelines for Americans</u>
    - Breakfast cereals limited to no more than 6 grams of added sugars per dry ounce
    - Yogurt limited to no more than 12 grams of addes sugars per 6 ounces (3 grams added sugar per oz.)
    - Tribal communities may substitute vegetables for grains and breads
    - State licensed health care professionals can write medical statements to request modifications on behalf of a child or adult with disabilities
