1. CALL TO ORDER, ROLL CALL – Dustin Gettel, Chair

2. CONSENT AGENDA

2.1. Approval of 11-2-23 Meeting Minutes

Kevin Severson motioned to approve, Arlyn Bradshaw seconded, all say aye.

3. DISCUSSION AND POSSIBLE ACTION ITEMS

3.1. 2024 Chair and Vice-Chair vote, Dustin Gettel, Chair

Dustin Gettel volunteered to continue serving as chair if approved. Arlyn motioned to have Dustin Gettel continue as Chair and Arlyn as Vice-chair. Linda Price seconded. All say aye.

3.2. Barkpass Online Licensing, Rob Naylor, Field Supervisor

Carrie Sibert and Robert Naylor explained that Animal Services has launched our updated online licensing feature through Barkpass. Robert Naylor demonstrated the process citizens will go through to license online using this application. Carrie also explained that Animal Services has developed some licensing marketing materials to distribute out to the jurisdictions to assist in spreading awareness and educate citizens on the importance of licensing.

Holly Smith asked if Animal Services has approached local vet clinics on licensing or if cities need to do that. Carrie explained Animal Services has discussed ideas regarding partnering with local businesses like vet clinics that can assist with increasing licenses. Animal Services is trying to work through some hurdles such as identifying clientele's jurisdiction, before proceeding but these ideas are being explored.

3.3. Open Meetings Act Training, Ryan Lambert, SLCO District Attorney

Ryan Lambert presented the annual training using the online open meetings act training through Utah.gov website found at:

The Committee completed the training as a group.

Gary Bowen asked for clarification on the rules for a majority vote. Ryan explained that the quorum requirements for specific voting items, such as going into and ending a closed session, need to be in excess of 2/3 or 66% of those in attendance. In most cases a simple majority suffices.

3.4. Legislative Updates, Talia Butler, Division Director

Talia Butler went over current bills in the 2024 legislative session that are related to animals. Talia went through each bill explaining what they involve, if there are concerns, and whether Animal Services in support of them or not. The Committee discussed how some of the current bills will affect Animal Services and their citizens. If Animal Services has some concerns with a bill we are working with sponsors and legislative teams to address issues.

3.5. Division Updates, Talia Butler, Division Director

Talia displayed a photo of our newly remodeled mobile spay/neuter clinic and how the program will assist in sterilizing and vaccinating owned pets in the community. A tour of the mobile unit and shelter will be scheduled for the next Advisory Committee meeting. The program has been funded through 2024 and we are hoping to get it funded through 2025.

Talia went over year ends stats from our general funded programs including microchipping, fostering, volunteering, and fundraising.

Talia went over our recent fundraising event celebrating Betty White's birthday.

Talia went over a successful adoption story regarding a veteran that adopted the dog through the Pets for Patriots program that Animal Services participates in to assist in uniting homeless pets with veterans.

Talia shared photos and highlighted a few of the programs available to the community including a humane education presentation made by our Humane Educator Hannah Black and her helper dog Banjo and information for an upcoming pet pantry event that assists citizens in need of pet food and pet supplies.

Talia went over the County's budget for 2024 and how that will impact Animal Services and our jurisdictions. Talia also highlighted that Animal Services has hired a second veterinarian.

Talia explained that we are looking at building an outbuilding on the shelter's property for additional kennel space to help address kennel space issues and increase our animal capacity. The overflow outbuilding is being funded through donation funds.

Talia updated the committee on the status of our Animal Care Campus survey. The survey has completed the 2nd wave and the third and final phase will soon launch. So far preliminary results show the community is highly supportive of the project.



2023 YEAR END STATS

Shelter Movements

- 6,326 total animals came into the shelter
- Of that 2,713 (43%) of them were reunited with their families.
- 685 went to Rescues.
- 2,277 were adopted
 - 1,131 cats
 - 1,048 dogs
 - 98 others.

Volunteer Hours

- 6,496 total volunteer hours
- 280 hours with cats
- 2,808 hours with dogs in our yards
- 1,718 on Hounds Around Town field trips
- 979 hours making treats for cats and dogs.
- Kids spent 180 hours reading to cats
- 173 hours at events
- 31 cats were transported by volunteers and then groomed for free by Meowser Pet Salon.

Hosted or Attended Events

- 49 hosted or attended events
- 95 animal adopt events
- 230 microchips were implanted
- We talked to 2,536 citizens about programs
- Sold 114 licenses
- Raised \$192,710 in donations
