NO ACTION COMMENTS

1. SCHEDULING. The City Recorder informed those at the meeting of upcoming events, meetings, activities, etc. Next Mtg—April 24th @ 7pm.

2. PUBLIC COMMENTS/QUESTIONS.

South Salt Lake resident, Susan Bowlden, in reference to the Flash Vote Survey results, talked about speeding issues in the City and said that she would like the Police Department to come down harder on speeders. She also talked about a time

where her neighborhood had to get clean drinking water from the Fire Department and was glad to see that water quality was still a priority amongst residents for the budget.

South Salt Lake resident, Lorrina Heisey, shared her thoughts and support regarding the attendance policy discussion item from the preceding Work Meeting. She said that as the Council Members are getting paid a salary, they should be present for scheduled meetings and be accountable to the taxpayers.

South Salt Lake resident, Conrad Campos, shared his thoughts and support regarding the attendance policy discussion item from the preceding Work Meeting. He said that with the technology available today, anyone can attend almost anything remotely. He also addressed speeding issues that he encounters every day on 500 East, 300 East, State Street, and West Temple. He would like to see the traffic division in the Police Department be more engaged with these areas during the times that speeding happens the most.

3. MAYOR COMMENTS.

Mayor Wood spoke about some upcoming events and City highlights.

- a. April is Fair Housing month and there will be a proclamation to highlight the importance of housing ready for the next meeting.
- b. April 22nd-26th is 'After School Professionals Appreciation Week' and she wanted to thank everyone who is a part of any effort in providing after school programming to kids.
- c. April 13th This will be the first 'Park Tour' where residents can take about a 90-minute tour of the City's parks from 10-11:30 am. More information can be found online on the City's calendar.
- d. April 20th This will be the second 'Park Tour' where residents can take about a 90-minute tour of the City's parks from 10-11:30 am. More information can be found online on the City's calendar.
- e. April 20th 'Earth Day Cleanup' will be held at the Jordan River Trail from 10 am-1 pm. Residents can take a bike ride along the trail and pick up trash. More information can be found online on the City's calendar.
- f. April 24th 'Housing Resource Fair' will be held at the South Salt Lake Community Center from 5-7 pm and provide resources and services for renters, homeowners, and first-time homebuyers.
- g. May 4th 'Homebuyer Education Workshop' will be held at the South Salt Lake Community Center from 9:30-2:30 pm. The course will teach how to navigate the complexities of buying a home. Residents will need to register online through the City's calendar.
- 4. CITY ATTORNEY COMMENTS.

5. CITY COUNCIL COMMENTS.

Council Member Sanchez addressed the most recent Civilian Review Board meeting and the statement that the CRB Board made regarding his online complaints about them.

Council Member Pinkney talked about Earth Day and encouraged everyone to come and join the Jordan River Trail clean up on April 20th.

6. INFORMATION.

a. CRB Quarterly Report

Civilian Review Board Chair, Joy Glad, went over some brief information of what the Civilian Review Board is, isn't, as well as what it oversees and doesn't oversee.

She started by saying that the Civilian Review Board is not an investigative body. She further clarified this by stating that they don't investigate police officers, the police department, any elected officials, or city staff. They strictly look at use-of-force cases generated by the police department's officers. Use-of-force is defined as arrest control techniques, body wraps, firearms, oleoresin capsicum (otherwise known as pepper spray), tasers, k-9's, less than lethal weapons, vehicular or foot pursuits.

She also clarified that the Civilian Review Board members are not City employees, staff, or elected officials. They are private residents who live in the City and are paid a stipend for every meeting they attend, but not for the work they may do outside of meetings (reviewing information and documents about upcoming cases prior to meetings).

The board is made up of seven voting members, two alternate members, and one none-voting advisory member. They are individuals who want to help the community by aiding in the transparency between the police department and the residents of South Salt Lake. They serve as a second set of eyes to review use-of-force cases and give recommendations to the police department for improvements. They also provide quarterly and annual reports to the City Council and, by proxy, the public.

The Civilian Review Board, like the City Council, must follow the Utah Open and Public Meetings Act (Utah Code 52-4-101 et seq) by noticing their meetings, agendas, and minutes on the City's website and the Utah Public Notice Website. They must also have a quorum to meet. They also regularly go into Closed Door Meetings under Utah Code Annotated, 1953, Sec. 52-4204, Sec. 52-4-205 (1)(a), et seq. to solely discuss the use-of-force cases in detail and in private, with a city attorney present to ensure that they remain on topic and that no votes are taken.

She then went over the highlights of the 1st quarter for 2024. From January to March, the CRB Board reviewed 33 cases, and found zero to be in any violation of Federal, State, and City rules and policies. There were four cases that required significant discussion, and a total number of one ride along that was done as a part of the quarterly Board requirements. There were zero citizen complaints, and one recommendation that the CRB Board has forwarded to the Police Department. Based on some feedback from residents, the desire for better visibility for the sides of police vehicles has been made known to the department.

Council Member Sanchez wanted to know if there was an internal affairs investigation in regard to his arrest in March. Ms. Glad said that there wasn't, and that if there was one, they wouldn't be involved in it.

Council Member Sanchez then asked why he wasn't notified of this meeting in advance. Ms. Glad said that they met all noticing requirements by posting the meeting and its agenda on the websites, as required by State law.

Council Member Williams asked for more clarity on the recommendations that the Board has made to the police department this quarter.

Ms. Glad said that the City's police vehicles don't have anything on their sides that shines or reflects so when officers are pulled in an angle or parked on the street it can be difficult to see them since it's just a white vehicle. The Board has recommended that the department look for ways to have better visibility to the public.

b. Adopt a Storm Drain

Stormwater Division Manager, Corby Talbot, and Stormwater Tech and Outreach Coordinator, Spencer Dunn, talked about 'Adopt a Drain', a nationwide clean-water program, that works with cities to protect water and waterways. The City is using this online portal to have residents sign up and adopt a drain and join in the City's efforts to keep its drains clear of debris. Residents can go to adopt-a-drain.org for more information.

The City operates under an MS4 (Municipal Separate Storm Sewer System) permit through the State which gives the City six minimum control measures that they are required to meet. Control measure #2 is about public involvement/participation. The 'Adopt a Drain' program would help to meet that requirement.

The program would track the data input by participants and provide that to

the City to be able to report and provide it as information to the public.

Council Member Williams asked if residents would need to lift the grates off the top of the drains.

Mr. Talbot and Mr. Dunn both answered that residents didn't need to lift the tops and clean inside, simple clear debris off the top of drains.

Council Member Sanchez asked what the cost of using this program was to the City.

Mr. Talbot didn't know at the moment and said that they would be happy to provide the exact numbers to the Council for the next meeting.

MS4 Permit(Municipal Separate Storm Sewer System)

4.2.2. Public Involvement/Participation

The Co-Permittee shall implement a program that complies with applicable State and Local public notice requirements. The SWMP shall include ongoing opportunities for public involvement and participation, but at a minimum two (2) times annually. Permittees can meet this requirement through advisory panels, public hearings, watershed committees, stewardship programs, environmental activities, other volunteer opportunities, or other similar activities. The Co-Permittee should involve potentially affected stakeholder groups, which include but is not limited to, commercial and industrial businesses, trade associations, environmental groups, homeowners associations, and education organizations. The minimum performance measures are:

4.2.2.1. Co-Permittees shall adopt a program or policy directive to create opportunities for the public to provide input during the decision making processes involving the development, implementation and update of the SWMP document including development and adoption of all required ordinances or regulatory mechanisms.

4.2.2.2. Renewal Co-Permittees shall make the revised SWMP document available to the public for review and input within 180 days from the effective date of this Permit. New Permittees shall make the SWMP document available to the public for review and input within 180 days of receiving notification from the Director of the requirement for Permit coverage.

4.2.2.3. A current version of the SWMP document shall remain available for public review and input for the life of the Permit. The Co-Permittee shall post the latest version of the SWMP within 180 days from the effect date of the Permit on their website and shall clearly denote a specific contact person and phone number or email address to allow the public to review and provide input for the life of the Permit.
