**A RESOLUTION OF THE REDEVELOPMENT AGENCY OF TAYLORSVILLE CITY BOARD  
ADOPTING A FINAL BALANCED BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1,  
2024 AND ENDING JUNE 30, 2025.**

**WHEREAS**, the Redevelopment Agency of Taylorsville City Board (the "Board") met in a properly noticed meeting on May 15, 2024, to consider, among other things, adopting a final balanced budget for the fiscal year beginning July 1, 2024, and ending June 30, 2025, a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference; and

**WHEREAS**, on May 1, 2024, the Tentative Budget was made available for public inspection; and

**WHEREAS**, on April 26, 2024,, notice of a public hearing to consider the Tentative Budget was published on the Utah Public Notice website; and

**WHEREAS**, on April 26, 2024, notice of a public hearing to consider the recommended amendments was published on the homepage of the City's website; and

**WHEREAS**, on May 1, 2024, a public hearing to receive public comment and consider the Tentative Budget was held at 6:15 p.m., or a short time thereafter, in the Council Chambers located at 2600 West Taylorsville Boulevard, Taylorsville, Utah; and

**WHEREAS**, all interested persons in attendance at the public hearing were given an opportunity to be heard, for or against, the estimated revenues and expenditures, or any other item thereof in the Tentative Budget for the 2024-2025 fiscal year; and

**WHEREAS**, the Board has determined that adopting the Tentative Budget with any amendments the Board has directed is in the best interest of the City, its residents, and businesses; and

**WHEREAS**, the Board desires to adopt the Tentative Budget as its 2024-2025 Fiscal Year Budget.

**NOW, THEREFORE, BE IT RESOLVED** that the Redevelopment Agency of Taylorsville City Board hereby adopts the Tentative Budget as presented to the Board as its 2024-2025 Fiscal Year Budget.
