#### IV. Public Comment

A. Emily Koelliker addressed the board regarding the proposed cell phone policy. She believes that students need to learn proper boundaries in cell phone usage, and she is glad that the board is working on a policy.

Jennifer Yates commented on the proposed cell phone policy. She appreciates the depth and thought that has been put into the policy. She is concerned that teacher discretion has been removed from the policy. She would like to allow her students to have access to their cell phones at teacher discretion.

Anson Clarkson addressed the board on the cell phone policy. He doesn't believe that students should be allowed to use their smart phones during class time. He believes that social media has led to high levels of teen suicide. He contends that cell phones/social media is destroying our youth.

Tiffany Unsworth addressed the board. Her family has lived in Kanab for the past ten years. She commented that her children have had access to world class education in Kane School District. She would like to give teachers the latitude to make decisions in their classrooms.

## V. Reports

A. Comprehensive Guidance Presentation VHS, KHS, KMS

VHS Counselor Ashley Chamberlain addressed the board and presented the Valley High Comprehensive Guidance Presentation. VHS has a 100% graduation rate since 2013. Everything done in the VHS guidance is data driven. Needs have been identified and the counseling program is based on these needs. VHS holds parenting seminars. VHS maintains a student care list. Every student has a caring adult assigned to them to make sure their needs are met. Mrs. Chamberlain is very involved in the classroom and in providing tier 1

intervention when needed. She also teaches students methods to deal with anxiety and social-emotional needs. Mrs. Chamberlin is going to conduct a Summer Mindfulness program for VHS students during the summer. The board thanked Mrs. Chamberlain for all her hard work with the VHS students.

KHS Counselor Chad Castagno thanked the board for all their support in providing funding to meet student needs. He reported on Hope Week. This included instruction on positive mental health and positive attitudes. They also had college education week. 65 pf 76 students participated in these activities. This includes information on different college career opportunities. He has 14 students in the cosmetology program. KHS has seven students that will receive associate degrees this year through the concurrent enrollment program. KHS also run a Keys to Success program. Over \$62,000 has been donated by Kanab businesses to fund scholarships for graduating seniors this year. SouthWest Tech College will offer a welding class next year. This year students have been riding a bus to Cedar City to attend classes at the SouthWest Tech College in Cedar City. Marc asked Chad if he has sufficient help. He stated that having Amber Hooper on staff has been a huge help.

Amber Hooper is the counselor for Kanab Middle and Kanab High. She presented a comprehensive counseling program for Kanab Middle School. She surveyed students as to top needs and some of the top needs were sadness issues and insecurity issues in their homes. She has an objective to increase parent support of PCCR meetings. She has met with most middle school students and parents. She has been working with Principal Bateman to make sure that student needs are being met. They have looked at what is going on in the elementary school and then deciding what needs to be continued at the middle school level. They took the eighth-grade students to SUU for college awareness week. They picked the March Madness and learned facts about College Awareness. KHS students commented in feedback that suicide prevention was the highest need for student awareness. She thanked Chad and Ashley for all the help they have given her.

#### B. School Board Report

Supt. Dalton thanked the counselors for excellent reports and for all the help they provide to students.

## C. Superintendent Report

#### D. Kane District Enrollment

Student enrollment in March was 1485, which was a decrease of two students from the February count of 1487. This includes the 25 BWS students that are bused to Page and 81 preschool students.

#### E. USBE Update

The State Board of Education has approved the LETRS reading program. The State board is now requiring that students be bathroom trained before going to full day kindergarten.

#### F. KSD School Binder Update

Supt. Dalton updated the board on this program. Parents and/or Grandparents can opt to receive school information through this system. Coaches and parents

can post information on this site. It is a one-way messaging board out-going. Students or people can respond in the chat feature. This platform provides a safe platform for teachers to communicate with students and parents and the public. Building principals would need to approve content before it goes out. The approval process is a two-step approval process. The cost is \$1 per student, per year.

## G. 2024 Legislative Summary

Many new bills passed during the recent legislative session. School Safety is a top priority. An SRO or an armed guard must be located in each school.

## H. Safe Routes to School Letter Kanab City

Supt. reported that Kane District Officials recently met with Kanab City officials and discussed needed improvements to increase student safety.
